3. Section 23 of the act 10 George V, chapter 141, is replaced by the following:

"**23.** The decision of the committee of management, as to admission of members, the report of either board of examiners, when an examination is required, or as to censure, suspension or expulsion of members, shall be final and without appeal, and the said committee shall be the sole judge of the qualifications of applicants for membership and of the conduct and competency of members whose censure, suspension or expulsion is decided on.

No refusal

Nothing contained in this section can be interpreted as giving the right to the committee of management to refuse, for want of capability, the persons who are entitled to be admitted under section 8 of the act 10 George V, chapter 141, and under sections 8a and 8b of the said act as enacted by section 2 of the act 12 George V, chapter 131.

C H A P. 132

An Act to incorporate *La Société des Missions Etrangères de la Province de Québec*

[Assented to, 8th of March, 1922]

Preamble.

WHEREAS His Eminence Cardinal Louis Nazaire Bégin, Archbishop of Quebec; Paul Eugène Roy, Archbishop of Seleucia, Coadjutor of the Archbishop of Quebec; Joseph Médard Emard, Bishop of Valleyfield; Michel Thomas Labrecque, Bishop of Chicoutimi; Paul Larocque, Bishop of Sherbrooke; François Xavier Cloutier, Bishop of Three Rivers; Joseph Simon Hermann Brunault, Bishop of Nicolet; Alexis Xiste Bernard, Bishop of Saint Hyacinthe; Elie Anicet Latulippe, Bishop of Haileybury; Patrick Ryan, Bishop of Pembroke; Georges Gauthier, Bishop of Philippo-

polis, Apostolic Administrator of Montreal; Guillaume Forbes, Bishop of Joliette; Louis James O'Leary, Bishop of Charlottetown, and François Xavier Ross, V.G., Administrator of the diocese of Rimouski; have, by their petition, represented that to better organize, assure and direct the participation of the Catholics of the Province of Quebec in the propagation of the Roman Catholic Faith, it is desirable that they should be incorporated; and

Whereas it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. His Eminence Cardinal Louis Nazaire Bégin, Archbishop of Quebec, and the other prelates herein above named, archbishops and bishops whose territory is wholly or in part in the Province of Quebec, as well as the administrators of the archdiocese of Ottawa and of the diocese of Mont-Laurier, and the persons who, according to the rules which will be made for that purpose, will succeed them or will be joined to them and will become members of the corporation, shall be incorporated under the name *La Société des Missions Etrangères de la Province de Québec*, with perpetual succession, and with the rights, powers and privileges belonging to ordinary civil corporations.

2. The corporate seat of the corporation shall be in the city of Montreal.

3. The object of the corporation is to undertake, and pursue, favour and aid works conducive to the propagation of the Roman Catholic Faith; to organize and assure the participation of the Catholics of the Province of Quebec in foreign Catholic missions, especially in the countries of the far east; to come to the help of those who desire to devote themselves to these missions; to favour the vocations and recruiting of missionaries, and to furnish them with means of appropriate studies and formation.

4. To attain these ends, the corporation may use means, not contrary to the law, which may be deemed useful to these undertakings, especially: the establishment, the maintenance and the direction of boarding-schools, noviciates, seminaries, houses for study and training for missionaries; the soliciting, receiving, use and distribution of aid; propagation by word and by writings; the publication of bulletins and reviews, and all other means of action suited to its objects.

5 The corporation may have a seal and change it at will; appear before any court of justice; acquire and receive by purchase, exchange, lease, donation, transfer, cession, assignment, legacies, or otherwise, and possess under any legal title moveable and immoveable property; administer the same, and derive revenues therefrom; lease, sell, exchange or otherwise dispose of same, in whole or in part, by any title whatsoever; administer its funds as it may deem fit; and make all kinds of legal investments including bonds, debentures or shares of other corporations or companies; borrow and contract obligations; hypothecate its immoveables; issue bonds or debentures, and guarantee the payment thereof by hypothec, pledge or mortgage, as the case may be and as it may desire; and, in general, exercise the rights of civil corporations and the powers which may conduce to the realization of its objects or to the working of its means of action and to the carrying out of its enterprises. But the annual revenue of the immoveables possessed by the corporation for revenue purposes must not exceed fifty thousand dollars.

6. For the transacting and administering of its business and property; the use of its funds; its organization and its government; the creation and receiving of revenues; the direction and conduct of its various services; the number, choice, appointment, resignation, retirement and replacing of its members; the creation, organization, powers and government of its council of direction; the number, appointment, duties and remuneration of its officers, employees and servants; the adoption, modification, the putting in force and the repeal of its rules, ordinances and deliberations; and generally for all that regards its object, its direction, its government, the exercise of its powers, and its works, the corporation may adopt the regulations and deliberations which it may deem opportune, provided that these regulations and deliberations be not contrary to the laws in force in this Province, nor to the rules established or which may be established by competent authority in the Roman Catholic Church.

7. Monseigneur Georges Gauthier, Bishop of Philipopolis, Apostolic Administrator of the diocese of Montreal, Monseigneur Paul Eugène Roy, Archbishop of Seleucia, and Coadjutor of Quebec; Monseigneur Guillaume Forbes, Bishop of Joliette, and Monseigneur Joseph Romuald Leonard, Bishop of Rimouski, shall form a provisional council of direction, charged with the exercise of the powers and rights of the corporation until it will be otherwise

provided for in conformity with the regulations which will be adopted.

8. The corporation shall transmit to the Lieutenant-Governor in Council, when thereunto required by the Provincial Secretary, a statement of its moveable and immoveable property and the names of its officers.

9. This act shall come into force on the day of its sanction. Coming into force.

An Act to incorporate the Connectional Methodist Church

WHEREAS the persons hereinafter named have, by Preamble.

Therefore, His Majesty, with the advice and consent of

Quebec, enacts as follows:
