C H A P. 152

An Act to authorize the Bar of the Province of Quebec to admit Max Liverman amongst its members

[Assented to, 8th of March, 1922]

Preamble.

WHEREAS Max Liverman, of the city of Montreal, Bachelor at Law, hath, by his petition, represented:

That he has been a student at law at the University of Montreal for three years previous to December, 1920, and was granted by the said university, the degree of Bachelor at Law, on December 18th 1920;

That he has been admitted to the study of law, having passed the examination on Sciences, on January 11th 1917, and on Letters, in the course of January 1920;

That he was under notarial indenture to Mr. Peter Bercovitch, King's Counsél, from January 25th 1917, to December 1920, and to Mr. Louis Fitch, Advocate, since the latter date;

That he has successfully passed the examination for admission to the practice of Advocate, in the month of July, 1921;

That he is thirty-one years old, and married;

That without the benefit of this act, the petitioner is exposed to lose considerable time, inasmuch as he would have needlessly followed the law course of the University of Montreal, and attended law offices from January 1917 to January 1921, the date on which his clerkship legally began;

That the General Council of the Bar, on the 29th day of September 1921, approved the passing of an act to authorize the Bar of the Province of Quebec to admit the petitioner amongst its members, as soon as such act is passed and sanctioned;

Whereas the petitioner has prayed that an act be passed for the above purposes and it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of

the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Bar of the Province of Quebec is hereby authorized to permit the said Max Liverman to practise as an advocate, and the secretary of the General Council of the Bar to issue to him his certificate as an advocate. Bar authorized to admit Max Liverman.

2. This act shall come into force on the day of its sanction. Coming into force.

C H A P. 153

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit Leopold Desforges to the practice of medicine and surgery, after examination

[Assented to, 8th of March, 1922]

WHEREAS Leopold Desforges, of the city and district of Montreal, has, by his petition, represented: Preamble.

That in September, 1912, he was admitted as a student of medicine and surgery of Laval University of Montreal, and that he followed the medical course of such university for the five years required;

That on account of poor health he suspended his studies for two years;

That in 1919, the said university granted him a diploma of Doctor of Medicine;

That in 1921 only, he obtained from the College of Physicians and Surgeons of the Province of Quebec the permission authorizing him to study medicine, which permission, for unavoidable causes, he was not able to obtain before entering the said university;

That, owing to the foregoing, the College of Physicians and Surgeons of the Province of Quebec has consented to the passing of an act authorizing the petitioner to practise medicine, after undergoing the medical examinations required for a license, before the board of examiners for the said college;

Whereas the petitioner has prayed for an act to that effect; and

Whereas it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:
