**3.** After the abolition of the said tolls as above-mentioned, the Lieutenant-Governor in Council may, from time to time, prescribe the terms upon which the said municipalities shall be made liable for the maintenance of the said road, as compensation for the abolition of the said tolls.

**4.** Upon the failure of one or other of the said municipalities to comply with the prescriptions enacted under section 3 of this act, the Lieutenant-Governor in Council may order that the necessary work be done under the authority of the Minister of Public Works and Labour, who shall be entitled to recover the cost thereof from the municipalities in default, by action before any court having jurisdiction.

## CHAP. 11

An Act to amend the act relating to the maintenance of provincial roads and of certain municipal roads, and the act relating to the maintenance of winter roads on certain provincial roads

[Assented to, 19th of March, 1921].

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Section 1 of the act 7 George V, chapter 10, is amended by adding thereto the paragraph following:

"In this act the expression: "regional road" means any road classified by the Minister of Roads as a regional road under section 1a."

**2.** The following sections are inserted in the act 7 George V, chapter 10, after section 1 thereof, to wit:

"**1a.** Whenever the Minister of Roads considers that it is required in the interest of any region of the Province, he may, by means of a notice published in the *Quebec Official Gazette*, and transmitted to the head of the municipal corporation having jurisdiction over such road, declare that, from and after such date as he fixes, any road shall be classified as a regional road.

**1b.** The Minister of Roads may, by means of a notice published in the *Quebec Official Gazette*, and transmitted to the head of the municipal corporation having jurisdiction over such road, declare that, from and after such date as he fixes, any road shall cease to be classified as a regional road.” May also put an end to classification of any road as such.

**3.** Section 2 of the act 7 George V, chapter 10, is amended: Id., s. 2, am.

*a.* by inserting therein, after the word: “provincial”, in the fifth line of the first paragraph thereof, the words: “and regional”;

*b.* by replacing the second paragraph thereof by the following:

“The contribution that may be exacted from any municipality traversed by a provincial road shall not be more than fifty per cent of the cost of the work done within its boundaries; and the contribution that may be exacted from any municipal corporation having jurisdiction over any road classified as a regional road shall not be more than fifty per cent of the cost of the work so done on such road. The Minister of Roads shall fix the proportion and the amount of such contributions, which may forthwith be recovered by the Provincial Treasurer, by action in his name. The certificate of the Minister shall be final, and shall establish beyond dispute that such debt is exigible from the municipal corporation in question.” Contribution from municipalities. Proportion to be fixed by Minister.

**4.** The title of the act 8 George V, chapter 59, is amended by inserting therein, after the word: “provincial”, the words: “and regional”. 8 Geo. V, c. 59, title am.

**5.** Section 1 of the act 8 George V, chapter 59, is amended by inserting therein, after the first paragraph thereof, the following: Id., s. 1, am.

“In this act the expression “regional road” means any road classified by the Minister of Roads as a regional road under section 1*a* of the act 7 George V, chapter 10.” “Regional road” defined.

**6.** Section 2 of the act 8 George V, chapter 59, is amended by inserting therein, after the word: “provincial”, in the third line thereof, the words: “and regional”. Id., s. 2, am.

**7.** Section 3 of the act 8 George V, chapter 59, is amended by inserting therein, after the word: “provincial”, in the second line of the first paragraph thereof, the words: “or regional”. Id., s. 3, am.

**8.** This act shall come into force on the day of its sanction. Coming into force.
