

CHAP. 15

An Act to amend the Revised Statutes, 1909, respecting
the registration divisions in Montreal

[Assented to, 19th of March, 1921]

HIS MAJESTY, with the advice and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

1. Article 74 of the Revised Statutes, 1909, as amended by the acts 1 George V (2nd session), chapter 10, section 2, and 7 George V, chapter 13, section 2, is again amended by replacing the word "seventy-seven", in the first line thereof, by the word "seventy-five".

2. Paragraphs 23, 46 and 47 of article 74 of the Revised Statutes, 1909, as amended by sections 31, 35 and 36 of the act 2 George V, chapter 9, are repealed.

3. The following paragraph is inserted in article 74 of the Revised Statutes, 1909, after paragraph 45 thereof:

<p>"46 Montreal.....</p>	<p>The counties of Jacques-Cartier, Maison-neuve, Montreal-Dorion, Montreal-Hochelaga, Montreal-Laurier, Montréal-St-Anne, Montreal-St-George, Montreal-St. James, Montreal-St. Lawrence, Montreal-St. Louis, Montreal-St. Mary's, Westmount, and that part of the county of Laval situated on the island of Montreal. Montreal."</p>

4. Article 7467 of the Revised Statutes, 1909, is amended by replacing the second paragraph thereof by the following:

First class. "The first class comprises the registration division of Montreal".

5. Articles 7471 and 7472 of the Revised Statutes, 1909, are repealed.

6. Schedule A of section eighteenth of chapter first of title twelfth of the Revised Statutes, 1909, which follows article 7531 of the said statutes, is amended by replacing the figures: "\$3,500", attributed to the first class in the first line thereof, by the figures: "\$5,000". Salary of registrar increased.

7. Schedule B of section eighteenth of chapter first of title twelfth of the Revised Statutes, 1909, which follows article 7531 of the said statutes, is replaced by the following: Schedule B. replaced.

"B.—(*Article 7470*)

"Division of the second class.....\$3,000 to \$3,500".

8. Schedule C of section eighteenth of chapter first of title twelfth of the Revised Statutes, 1909, which follows article 7531 of the said statutes, is repealed. Schedule C. repealed.

9. The registration divisions known under the names of the registration divisions of Hochelaga and Jacques Cartier, of Montreal East and of Montreal West, are abolished, and the territory comprised in such divisions shall hereafter form part of the registration division of Montreal. This last-mentioned division shall comprise the territory mentioned in paragraph 46 of article 74 of the Revised Statutes, 1909, as enacted by section 3 of this act. Territory comprising registration division of Montreal.

10. Every act in force respecting the registration of any title or deed, and every matter connected therewith or with any registry office, or any registrar or deputy-registrar appointed thereto, shall apply to the registration division of Montreal, established by this act, save any that may be incompatible therewith. Application of acts, etc.

11. The registry office of Montreal shall be in the city of Montreal, at the place fixed, from time to time, by proclamation of the Lieutenant-Governor in Council. Situation of registry office.

12. From and after the date fixed by proclamation for the coming into force of this act, every book, record, index, plan, document or paper belonging to the registry offices of Hochelaga and Jacques-Cartier, Montreal East or Montreal West, hereby abolished, shall be transmitted, at the diligence of the person appointed for such purpose by the Attorney-General, to the registry office of Montreal, to form part of the records of such office. Transmission of books, etc.

13. After the transmission of the documents mentioned Powers of registrar.

in section 12, the registrar of the registration division of Montreal shall be vested with every power, right and privilege belonging to the former registrars of the registration divisions abolished by virtue of section 9, and he may, with the same authority and for all purposes whatsoever, deliver any copy, extract or certificate, or do any act that the registrar of any of the divisions so abolished might deliver, perform or execute; but this provision shall in no way affect any responsibility incurred by the registrar of any division so abolished.

14. From and after the publication in the *Quebec Official Gazette* of the proclamation fixing the date of the coming into force of this act, the Lieutenant-Governor in Council may immediately appoint a registrar for Montreal, and the latter must forthwith obtain his commission, take the oaths of allegiance and of office, and subscribe his security, according to law. He may not, however, enter upon his duties before the date fixed for the putting into force of these provisions.

15. This act shall come into force on the day which the Lieutenant-Governor in Council may be pleased to fix by proclamation.

CHAP. 16

An Act to amend the Revised Statutes, 1909, respecting the property qualification for Legislative Councillors

[Assented to, 19th of March, 1921]

HIS MAJESTY, with the advice and the consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

R. S. 85,
replaced.

1. Article 85 of the Revised Statutes, 1909, is replaced by the following:

Domicile
and proper-
ty qualifica-
tion.

"85. Notwithstanding any of the provisions of the British North America Act, 1867, it is sufficient for any member of the Legislative Council to be domiciled, and to possess his property qualification, within the Province of Quebec."

2. This act shall come into force on the day of its sanction.
