

## C H A P. 17

An Act to amend the act 2 George V, chapter 9, respecting  
the alteration of the name of the County of Ottawa  
to that of Hull

[Assented to, 25th of February, 1921]

**H**IS MAJESTY, with the advice and consent of the  
Legislative Council and of the Legislative Assembly  
of Quebec, enacts as follows:

**1.** Article 97 of the Revised Statutes, 1909, as replaced R. S., 97,  
by the act 2 George V, chapter 9, section 65, is amended <sup>am.</sup>  
by replacing the word "Ottawa", in the thirteenth line  
thereof, by the word "Hull".

## C H A P. 18

An Act to amend the Revised Statutes, 1909, respecting  
the security to be given by public officers

[Assented to, 19th of March, 1921]

**H**IS MAJESTY, with the advice and consent of the  
Legislative Council and of the Legislative Assembly  
of Quebec, enacts as follows:

**1.** Article 610 of the Revised Statutes, 1909, is amended R. S., 610,  
by replacing the words: "and registrars", in the third line <sup>am.</sup>  
thereof, by the words: "registrars and the Superintendent  
of Public Instruction".

**2.** Article 611 of the Revised Statutes, 1909, is amended <sup>Id. 611, am.</sup>  
by inserting therein, after the word: "articles" in the first  
line thereof, the figures: "3270, 3302".

**3.** Article 634 of the Revised Statutes, 1909, is repealed. <sup>Id., 634, rep-</sup>

## CHAP. 19

An Act to amend the Revised Statutes, 1909, respecting the civil service

[Assented to, 19th of March, 1921]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Article 658*f* of the Revised Statutes, 1909, as enacted by the act 2 George V, chapter 11, section 6, and amended by the act 9 George V, chapter 15, section 1, is again amended by replacing the words: "nine hundred", in the seventh line thereof, by the words: "one thousand".
