

## C H A P. 36

An Act to amend the Revised Statutes, 1909, respecting  
agricultural societies

[Assented to, 25th of February, 1921]

**HIS MAJESTY**, with the advice and consent of the  
Legislative Council and of the Legislative Assembly  
of Quebec, enacts as follows:

R. S. 1792, **1.** Article 1792 of the Revised Statutes, 1909, as amend-  
am. ed by the act 8 George V, chapter 31, section 1, is again  
amended:

a. by replacing the word: "forty", in the third line there-  
of, by the word: "fifty";

b. by again replacing the third paragraph thereof by the  
following:

Annual  
subscription.

"From and after the 1st of January, 1922, the annual  
subscription shall be two dollars; but nothing shall prevent  
any member from voluntarily subscribing a sum larger than  
the annual subscription."

R. S. 1795, **2.** Article 1795 of the Revised Statutes, 1909, as amend-  
am. ed by the acts 1 George V (1st session), chapter 13, section  
1, 1 George V (2nd session), chapter 18, section 1, 2 George  
V, chapter 9, section 71, 2 George V, chapter 19, section 1,  
5 George V, chapter 14, section 19, 8 George V, chapter 32,  
section 1, and 9 George V, chapter 28, section 1, is again  
amended by replacing the first paragraph thereof by the  
following:

Division, etc.

**"1795.** The Lieutenant-Governor in Council may  
divide any county in the Province into two or three parts,  
designated by the letters A, B or C, as the case may be,  
or may re-unite into one any county so divided into two  
or three parts."

R. S. 1852, **3.** Article 1852 of the Revised Statutes, 1909, is amend-  
am. ed:

a. by replacing the word: "forty", in the first line thereof,  
by the words: "one hundred";

b. by replacing the word: "twenty-five", in the third  
line thereof, by the word: "fifty".

R. S. 1854, **4.** Article 1854 of the Revised Statutes, 1909, is amend-  
am. ed by replacing the word: "eighty", in the second line  
thereof, by the words: "two hundred".

**5.** Article 1856 of the Revised Statutes, 1909, as amended by the act 1 George V (1st session), chapter 13, section 9, <sup>am.</sup> 1856, is again amended:

*a.* by inserting therein, after the word: "society", in the second and third lines of the second paragraph thereof, the words: "provided it complies with the by-laws of the Council of Agriculture";

*b.* by striking out the words: "of at least one hundred dollars", in the fourth line of sub-paragraph *a* of the second paragraph thereof;

*c.* by replacing the words: "one hundred dollars", in the seventh and eighth lines of the said sub-paragraph *a*, by the words: "not more than two hundred dollars"; and

*d.* by adding, at the end of the said sub-paragraph *a*, the words: "but such subsidies shall in no case be for an amount greater than the premium;".

**6.** The Revised Statutes, 1909, are amended by inserting therein, after article 1857 thereof, the following: R. S. 1857<sup>a</sup>,  
enacted.

**"1857<sup>a</sup>.** If any society neglects, for two years, to comply with the provisions of this section, the Minister may declare it dissolved, may realize all its assets and employ the proceeds in paying the debts of the society, and any surplus of assets over liabilities may be used for the encouragement of agricultural institutions, and for the benefit of the interests of agriculture generally in the county where such society existed."

**7.** This act shall come into force on the day of its sanction Coming  
into force.

## CHAP. 37

An Act to amend the Revised Statutes, 1909, relating to  
the Dairy Association of the Province of Quebec, the  
inspection of butter and cheese factories and  
the manufacture of dairy products

[Assented to, 19th of March, 1921]

**HIS MAJESTY**, with the advice and consent of the  
Legislative Council and of the Legislative Assembly  
of Quebec, enacts as follows:

**1.** Article 1964 of the Revised Statutes, 1909, as re-placed by the act 5 George V, chapter 31, section 3, is repealed.
