An Act to amend the charter of the Montreal School for higher commercial studies

[Assented to, 19th of March, 1921]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Section 1 of the act 7 Edward VII, chapter 23, as 7 Ed. VII, amended by the act 10 George V, chapter 42, section 1, is^{c. 23, s. 1,} again amended by replacing paragraphs *a* and *b* thereof^{am.} by the following:

“*a.* Of the Provincial Secretary, who is a member thereof *de jure*, and who shall receive no compensation;

“*b.* Of the principal, who is a member thereof *de jure*;

“*c.* Of five persons chosen from among the members of *La Chambre de Commerce* of the district of Montreal, and appointed for four years by the Lieutenant-Governor in Council, which said five persons shall receive no compensation; but who, at the expiration of their term of office, may be re-appointed by the Lieutenant-Governor in Council.”

2. Section 4 of the act 7 Edward VII, chapter 23, as 7 Ed. VII, amended by the acts 8 Edward VII, chapter 30, section 2,^{c. 23, s. 4,} and 1 George V (1st session), chapter 21, section 2, is again^{am.} amended by replacing the figures: “\$50,000”, in the fifth line thereof, by the figures: “\$65,000”.

An Act to amend the charter of the Quebec technical school
