CHAP. 97

An Act respecting the putting into force of the cadastre in the townships of Matapedia in the county of Bonaventure, and of Aumond and Kensington in the county of Hull

[Assented to, 19th of March, 1921]

WHEREAS the Minister of Colonization, Mines and Fisheries has had plans of the township of Matapedia, in the county of Bonaventure, and Aumond and Kensington, in the county of Hull, prepared and deposited according to law, as well as the books of reference relating thereto; Preamble.

Whereas, under the provisions of article 2169 of the Civil Code, the deposit of the plans and books of reference in any registration division is declared by a proclamation from the Lieutenant-Governor in Council, fixing the day on which the provisions of article 2168 of the said code shall come into force therein;

Whereas the passing of the order in council required by article 2169 of the Civil Code, has been omitted, by error;

Whereas a proclamation from the Lieutenant-Governor in Council was issued on the 26th day of June, 1920, and published in the *Quebec Official Gazette* on the 3rd of July, 1920, fixing the 15th of July of the same year as being the date for the coming into force of the cadastre for the township of Matapedia, in the second registration division of Bonaventure;

Whereas a proclamation from the Lieutenant-Governor in Council was issued on the 14th day of June, 1920, and published in the same number of the *Quebec Official Gazette*, fixing the 15th of July of the same year as being the date for the coming into force of the cadastre for the township of Aumond in the registration division of the county of Hull;

Whereas a proclamation from the Lieutenant-Governor in Council was issued on the 14th day of June, 1920, and published in the same number of the *Quebec Official Gazette*, fixing the 15th of July of the same year as being the date for the coming into force of the cadastre for the township of Kensington in the registration division of the county of Hull;

Whereas such proclamations erroneously allege that the date of the 15th of July, 1920, fixed for the coming into force of the cadastre for the said townships, was so fixed by order in council; and

Whereas it is expedient to legalize such proclamations;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The proclamations, dated the 14th and 26th days of June, 1920, published in the number of the *Quebec Official Gazette* of the 3rd of July, 1920, fixing the 15th day of the said month of July as being the date for the coming into force of the cadastre for the township of Matapedia, in the second registration division of Bonaventure, and for Aumond and Kensington, in the registration division of Hull, shall be of the same validity, force and effect as if they had been issued pursuant to an order of the Lieutenant-Governor in Council.

2. This act shall be deemed to have been in force since the 3rd day of July last, 1920, the date of the publication of the said proclamation.

CHAP. 98
