

of its territory to an amount not exceeding a total of twenty thousand dollars per annum; such tax to be imposed and levied only for the amount which may be required for the purposes of such payment. Such tax shall subsist and be levied throughout such period of ten years, even in the event of the town of St. Michel being annexed to the city of Montreal or to any other municipality.

4. In the event of the town of St. Michel coming under the action of the Island of Montreal Metropolitan Commission, it may not exercise the powers conferred upon it by this act, save with the authorization of the said Commission. Proviso in case of control by Metropolitan Commission.

5. The following article is added for the town after article 5762 of the Revised Statutes, 1909: R. S., 5762a, enacted for the town.

"5762a. The town may become purchaser and acquirer, at these sales or at any other made by authority of justice, or at public auction, of the lands indebted to it for taxes, but such bids shall not exceed the amount necessary to ensure the payment of the taxes due to the town in capital, interest and costs. This power is considered to have existed for the town since the first of September, 1919, as regards any purchases of land which may have thus been made since such date. This provision shall only take affect if approved by the Island of Montreal Metropolitan Commission. Power to purchase certain property.

6. This act shall come into force on the day of its sanction. Coming into force.

CHAP. 127

An Act to amend the charter of the town of Kipawa

[Assented to, 25th of February, 1921]

WHEREAS the town of Kipawa has, by its petition, represented: Preamble.

That it desires to change its name to that of "Town of Temiscaming" and to have extended the delay fixed by its charter, the act 10 George V, chapter 110, for acquiring certain property from the Kipawa Company Limited; and

Whereas it is expedient to grant the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

10 Geo. V, c. 110, am. **1.** The act 10 George V, chapter 110, is amended by replacing by the word "Temiscaming" the word "Kipawa" wherever it appears as designating the town incorporated by such act, and such town, heretofore known as the "Town of Kipawa", shall henceforth be known and designated as the "Town of Temiscaming".

Change of name.

Change of name. **2.** The name "Kipawa", in sections 1, 2, 3, 4 and 20 of the act 10 George V, chapter 110, is hereby replaced by the name "Temiscaming".

10 Geo. V, c. 110, s. 32, replaced. **3.** Section 32 of the act 10 George V, chapter 110, is replaced by the following:

Town may take over streets, etc. from company.

"32. Within three years after the coming into force of this act, the town may take over from Kipawa Company, Limited, or from the Riordon Company, Limited, now owning and operating said Kipawa Company, Limited, all works already executed or to be executed, and now in course of execution, including all streets and squares shown on the plan or plans registered before the date of taking over the same, including also all sewers and sewer equipment and all property, plant, machinery, pipes, wires, poles, conduits, apparatus and equipment occupied or held and used or intended for the supply of water to the town and its inhabitants, or used or intended for fire and police protection and equipment and for other municipal purposes; and the town shall pay to the company therefor an amount equal to the cost of the construction, improvement, acquisition and installation thereof, and interest on such cost at six per cent per annum to the date of taking over the same.

Payment therefor.

Settlement of amount.

But such amount must first have been audited and certified as correct, and as representing the expenses actually incurred by the said company, by an accountant appointed by the Minister of Municipal Affairs."

Coming into force.

4. This act shall come into force on the day of its sanction.
