An Act to incorporate the parish of St. Philibert in the county of Beauce

[Assented to, 25th of February, 1921]

Preamble.

WHEREAS by their petition the following persons: J. O. Audet, priest, Pierre Rodrigue, Ernest Paquet, Joseph Drouin, Herménégilde Groleau, Georges Gagnon, Georges Bourque, all farmers, and Georges Brochu, manufacturer, of the parish of St. Philibert, in the district of Beauce, have represented:

That in virtue of a canonical decree dated the 19th of December, 1919, signed by His Eminence Cardinal Bégin, Archbishop of Quebec, and countersigned by Jules Laberge, priest, secretary, the parish of St. Philibert was canonically erected;

That the territory of the new parish erected as aforesaid consists of a portion of each of the municipalities of the parish of St. Côme, in the district of Beauce, the municipality of Aubert Gallion (parish of St. Georges), also in the county, of Beauce, and of the municipality of Watford West (parish of St. Prosper), in the county of Dorchester;

That it is expedient that the territory detached from the aforesaid municipalities be constituted a new and distinct municipality under the name of "The municipality of the parish of St Philibert de Beauce";

That in the territory forming the canonical parish of St. Philibert there is already a Roman Catholic church with a priest residing in the parish, and it is in the interest of all the ratepayers that the said territory be given a civil and distinct organization; and

Whereas it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Parish municipality incorporated.
Territory.

1. All the territory erected canonically having an area of about seven miles frontage by six miles in depth, and bounded as follows, to wit:

towards the northeast, by the dividing line between lots 17 and 18 of ranges VII, VIII and IX of the township of Watford, from there, by the dividing line of lots 29 and 30 of ranges A and B, township of Watford;

towards the southeast, by the south baseline of range A, township of Linière, as far as No. 42, inclusive, of the same range;

towards the southwest, by the dividing line of lots 42 and 43 of ranges A and B of the township of Linière, thence by the north baseline of range A, township of Linière, as far as the dividing line of ranges II and III of the said township of Linière;

towards the west, by the dividing line of the said ranges II and III as far as No. 12 inclusive, of range III; from there, following the dividing line of lots 22 and 23 of range II, thence following the dividing line of ranges I and II as far as the Belfast range; from there, continuing along the dividing line between the Belfast range and range II of the township of Linière, as far as the dividing line of lots 673 and 674 of the Belfast range and of lots 717 and 718 of the Ste. Marguerite range, township of Aubin de l'Isle;

towards the northwest, by the dividing line of ranges Ste. Marguerite and St. Antoine, township of Aubin de l'Isle, and of ranges VII and VI, township of Watford, as far as No. 18, inclusive, the starting point;—

is detached from the said municipalities of d'Aubert Gallion, St. Côme and West Watford to which it belonged, and shall cease to form part thereof; and is hereby constituted a distinct municipality under the name of "Municipality of the parish of St. Philibert de Name. Beauce".

2. The inhabitants and ratepayers of the parish of St. Name of Philibert shall form a corporation known under the name of corporation. "Corporation of the parish of St. Philibert de Beauce"; and the said municipality and the said corporation shall have all the powers conferred upon a municipality and parish corporation by the Quebec Municipal Code, and shall also be governed by the said Quebec Municipal Code.

3. The municipality of the parish of St. Philibert de To form Beauce shall, for all purposes, form part of the county of part of the Beauce. county of Beauce.

4. This act shall come into force on the day of its Coming sanction. into force.
