## An Act to incorporate the municipality of Notre-Dame de Lourdes de Lorrainville

[Assented to, 25th of February, 1921]

**W**HEREAS Messrs. Napoleon Bouchard, merchant; Preamble.

Hyacinthe Lasalle, merchant; Michel Theroux, painter; and Eugène Dallaire, labourer, all four of the parish of Notre-Dame de Lourdes de Lorrainville, county of Temiscaming, have, by their petition, represented:

That by a proclamation of the Lieutenant-Governor of the Province, dated the 2nd of February, 1911, the limits and boundaries of the canonical parish of Notre-Dame de Lourdes de Lorrainville, in the county of Temiscaming, were described and determined as follows:

1. In the township of Duhamel, the lots, all inclusive: a. from No. 14 to No. 62, of the fifth range; b. from No. 14 to No. 59, of the sixth range; c. from No. 16 to No. 58, of the seventh range and the parts of lots Nos. 13, 14 and 15 of the latter range, situated to the north of the little Blanche river;

2. In the township of Laverlochère the lots, all inclusive: a. from lot 25 to lot 47, of the first and second ranges; b. from lot 32 to lot 47 of the third range;

That, by the said proclamation, the said limits and boundaries above described were confirmed, established and recognized;

That it was declared and ordered by the said proclamation that the parish of Notre-Dame de Lourdes de Lorrainville, described as aforesaid, should be a parish for all civil purposes;

That by a proclamation of the Lieutenant-Governor dated the 18th of November, 1911, lots Nos. 45 to 47, inclusive, of the second and third ranges of the township of Laverlochère, were detached from the canonical and civil parish of Notre-Dame de Lourdes de Lorrainville, to be annexed to the canonical and civil parish of St. Isidore;

That, since the said proclamation, the said parish of Notre-Dame de Lourdes de Lorrainville, less the lots Nos. 45 to 47, inclusive, of the second and third ranges of the township of Laverlochère, has been administered, for municipal purposes, as a distinct parish municipality, under the name of: "Municipality of the parish of Notre-Dame de Lourdes de Lorrainville", and, for school purposes, under the name of "School Municipality of Notre-Dame de Lourdes de Lorrainville";

That, since the said proclamation, a municipal council and a school commission for the said parish have been appointed and have acted as such;

That, considering the present state of affairs, it is necessary that an act be passed erecting as a parish municipality the whole territory now constituting the canonical and civil parish of Notre-Dame de Lourdes de Lorrainville;

That it is necessary to erect the whole territory of the said parish as a school municipality;

That it is necessary, at the same, time, to ratify the by-laws, resolutions, minutes, orders lists, rolls or acts adopted by the said council and school commission; and

Whereas it is expedient to grant the prayer of the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

| School municipality incorporated. | <b>3.</b> The whole of the territory now constituting the canonical and civil parish of Notre-Dame de Lourdes de Lorrainville, as described in the preamble to this act,—less lots 45 to 47, inclusive, of the second and third ranges of the township of Laverlochère—is erected as a school municipality under the name of: "School Municipality of Notre-Dame de Lourdes de Lorrainville".                   |
| By-laws, etc., to be valid.       | <b>4.</b> All by-laws, resolutions, minutes, orders, lists, rolls or other acts adopted or passed by the school commissioners of the said parish of Notre-Dame de Lourdes de Lorrainville, from the date of its existence, are deemed to have been adopted or passed by school commissioners legally capable of performing such acts.   |

**5.** The costs incurred by the petitioners, as well as all the disbursements and fees of their advocates in connection with the passing of this act, shall be paid by the municipality of the parish of Notre-Dame de Lourdes de Lorrainville. Costs of this act.

## CHAP. 134

An Act to incorporate the municipality of the parish of  
St. Mathieu

[Assented to, 19th of March, 1921]

**W**HEREAS Pierre E. Roy, *curé* of the canonical parish of St. Mathieu, Isaïe Lefebvre, Philippe Laferrière, Modeste Trudeau, Arthur Trudeau, Léon Trudeau, Wilfrid Cédilot, member of the Legislative Assembly for the county of Laprairie; Pierre Cédilot, Arthur Poitevin, Léonidas Bonneau, Gustave Derome and several other ratepayers forming the majority of the canonical parish of St. Mathieu, situated partly in the county of Napierville, and partly in the county of Laprairie, and Edmond Boire, of the parish of St. Philippe, have, by their petition, represented: that this canonical parish, besides lot No. 284 of the plan and book of reference of the parish of St. Philippe, now consists and forms part of four different local municipalities; that this causes serious inconvenience and that it is advisable that this canonical parish, with the addition of lot No. 284 of the plan and book of reference of the parish of St. Philippe, be erected into a separate local municipality; and

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The parish of St. Mathieu, as canonically erected, situated in the municipalities of St. Constant and St. Philippe, in the county of Laprairie, and St. Edouard and St. Michel Archange, in the county of Napierville, and lot No. 284 of the plan and book of reference of the parish of St. Philippe, in the county of Laprairie, shall henceforth form a local municipality, entirely within the county Parish municipality incorporated.
