

15. The secretary shall, every year, cause to be printed, published and kept, free of charge, for the information of the public, in his office, an exact register containing, in alphabetical order of the family names, mentioning their respective residence, the names of all persons appearing on the general register on the first day of January of each year. Such register shall be called "Register of the Forest Engineers of the Province of Quebec"; and a copy of such register, appearing to have been printed and published as aforesaid, shall be considered in all courts of justice and before all justices of the peace and other magistrates as *prima facie* proof that the persons mentioned in the said register are therein registered according to the provisions of this act; but if it should happen that the name of any person should not appear in the said copy over the signature of the secretary, the fact that the name of such person is entered in the register itself shall be considered as proof that such person has been entered in accordance with the provisions of this act.

16. The persons named in section 1 shall constitute the first board of management, and shall remain in office until their successors shall have been regularly appointed.

17. Nothing in this act shall be considered as affecting the rights and privileges conferred upon the members of the corporation of professional engineers of Quebec, the members of the corporation of Quebec land surveyors, the universities of the Province of Quebec and the Montreal Polytechnical School.

C H A P. 144

An Act respecting Brown Corporation

[Assented to, 19th of March, 1921]

WHEREAS Brown Corporation has, by its petition, represented that it has, under the provisions of its charter, the act 5 Edward VII, chapter 84, as amended by the acts 7 Edward VII, chapter 101, and 5 George V, chapter 119, acquired the whole of the shares of the Beau-rivage Lumber Company, a company incorporated by letters patent under the Quebec Companies' Act, 1907, bearing date the 10th day of September, 1908, and the

whole of the shares of the Saint Lawrence Lumber Industrial Company, a company incorporated under the same act by letters patent bearing date the 27th day of January, 1908, and is desirous of taking over the assets, obligations, rights and undertakings of the said two companies, and of exercising in its own name and right their powers as enumerated in and conferred by the said letters patent, and has prayed that its said charter be amended in the manner hereinafter set forth;

And whereas it is expedient to grant the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

5 Ed. VII, c. 84, s. 5, am. **1.** Section 5 of the act 5 Edward VII, chapter 84, is amended by adding thereto the following paragraph:

To take over certain companies as going concerns. “*g.* Specially and without limiting the generality of the foregoing terms, acquire, take over as going concerns, carry on and operate the undertakings, properties, rights, plants and other assets and assume the obligations of the Beaurivage Lumber Company, a company incorporated by letters patent under the Quebec Companies’ Act, 1907, bearing date the 10th day of September, 1908, and of the Saint Lawrence Lumber Industrial Company, a company incorporated under the said act by letters patent bearing date the 27th day of January, 1908, and have and exercise in its own name the powers enumerated in and conferred by the said letters patent.”

CHAP. 145

An Act to amend the charter and to define the powers of
The Winchester Club

[Assented to, 19th of March, 1921]

Preamble. **W**HEREAS the Winchester Club, Incorporated, has by its petition represented:

That by letters patent under the great seal of the Province of Quebec granted on the 21st day of January, 1912, it was constituted a body politic and corporate under the name of “The Winchester Club, Incorporated”, and

That it is desirable in the interest of the club that its charter be amended and its powers defined, and has prayed
