## CHAP. 152

### An Act to incorporate "*L'Orphelinat Apostolique de la Malbaie*"

[Assented to, 19th of March, 1921]

**W**HEREAS Mesdames Marie Calixte Boily, in religion Preamble.

Sister Marie de l'Eucharistie; Sara Brassard, in religion Sister Marie Salomé; Odile Tremblay, in religion Sister Marie du Calvaire; Eugénie Martin, in religion Sister Marie de Ste Germaine; Rose Anna Roy, in religion Sister Marie de Ste Anne; all of the village of Malbaie, have by their petition represented:

That *l'Orphelinat Apostolique de la Malbaie* was founded for the purpose of receiving, rearing and educating orphans;

That this institution has received the approval of the Roman Catholic religious authority of the diocese of Chicoutimi;

That it has become necessary, in order to assure the permanence and the future proper administration of the work above mentioned, to confide it to a regularly organized corporation;

That the persons above mentioned represent the interests in connection with this work, and have, by their petition, prayed for an act to incorporate them for such purpose, under the name of "*L'Orphelinat Apostolique de la Malbaie*", with the rights, powers and privileges hereinafter set forth; and

Whereas it is expedient to grant such prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Mesdames Marie Calixte Boily, in religion Sister Corporation  
Marie de l'Eucharistie; Sara Brassard, in religion Sister created.  
Marie Salomé; Odile Tremblay, in religion Sister Marie  
du Calvaire; Eugénie Martin, in religion Sister Marie de  
Ste. Germaine; Rose Anna Roy, in religion Sister Marie

Name. de Ste. Anne, all of the village of Malbaie, and all other persons who may, in accordance with the by-laws passed for that purpose, succeed them or be associated with them and become members of such institution, are incorporated under the name of "*L'Orphelinat Apostolique de la Malbaie*".

Corporate seat.

**2.** The corporate seat of the corporation shall be in the village of La Malbaie, in the county of Charlevoix. The parish priest of La Malbaie shall be *ex officio* a member of the board of management.

Powers.

**3.** The corporation shall have all the rights, powers and privileges appertaining to ordinary civil corporations, and may,—

- a. have a common seal, and alter it at will;
- b. appear before the courts;
- c. accept, acquire and possess by all means recognized by law, rights and moveable property, provided that the annual revenues from the immoveables belonging to the corporation and owned by it for the purposes of revenue, shall not exceed fifty thousand dollars;
- d. administer such property and receive the revenues therefrom, lease, sell, exchange, cede and alienate under any title whatsoever, or otherwise dispose of such property;
- e. borrow and contract obligations, and pledge and hypothecate its property and immoveables;
- f. adopt for its organization and government, for the renewal of its members, their admission and resignation, their rights and duties, the choice, nomination and attributes of its officers, the administration of its property, and the investment of its funds, and generally for everything connected with this object, for the carrying out of its undertaking, and the direction of its work and the exercise of its powers, all by-laws, ordinances and deliberations it may deem advisable, provided that such contain nothing contrary to the laws of this Province;
- g. appoint officers or administrators among its members and define their powers; also choose and appoint procurators or administrators outside of their body.

Powers.

**4.** The corporation may, subject to the approval of the religious authority, undertake the various works appertaining to the *Communauté Saint-Antoine de Padoue de Chicoutimi*, among others, receive poor children, see to the instruction and education of youth, establish and maintain new

orphan asylums in any place in the Province of Quebec, and, for the purpose of education and instruction, it may establish workshops and agricultural, housekeeping or other industries, and sell the proceeds thereof for the benefit of its works.

**5.** The persons above mentioned shall constitute the Provisional board of provisional directors for the purpose of exercising directors. the powers of the corporation, until otherwise provided for, in accordance with by-laws that may be adopted.

**6.** The corporation shall send every year to the Provincial Secretary a statement of its moveables and immove- to Prov. Sec. ables, and the names of its officers.

**7.** This act shall come into force on the day of its Coming into force. sanction.

#### CHAP. 153

### An Act to incorporate the Educational and Charitable Institute

[Assented to, 25th of February, 1921]

**W**HEREAS William Joseph O'Leary, electrical engineer; Preamble. Noah Timmins, financier, and David R. Murphy, public officer, all three of the city of Westmount, in the Province of Quebec, have, by their petition, represented that their constitution into a body politic and corporate without share capital under the corporate name of "The Educational and Charitable Institute", is advantageous in the public interest and for themselves;

Whereas they have applied to be so incorporated and to be vested with the necessary powers as hereinafter mentioned; and whereas it is expedient to grant their prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The persons above named, their successors and such Corporation others as may become members of the corporation hereby created. created, are hereby incorporated as a body politic and corporate without share capital under the corporate name Name. of the "Educational and Charitable Institute".

**2.** The object and purpose of the corporation shall be Objects.
