

tion of mem- any remuneration for their services as members thereof, but the corporation may employ and pay for the services of any one or more corporations, associations or individuals; the corporation may appoint an attorney or attorneys at such salary or salaries as may be agreed upon, for the management of its affairs and the protection of its interests.

Interpre- **20.** Nothing in this act contained shall have the effect of granting to the corporation the right of exercising the privileges and prerogatives generally possessed by the university corporations entrusted with superior or secondary education.

Statement to Lt. Gov. in C. **21.** The corporation shall transmit to the Lieutenant-Governor in Council, when thereunto required by the Provincial Secretary, a detailed statement of its moveable and immoveable property, the names of its officers, and a certified copy of its rules and regulations.

Coming into force. **22.** This act shall come into force on the day of its sanction.

## C H A P. 154

### An Act to incorporate *Le Refuge Dom Bosco*

[Assented to, 25th of February, 1921]

Preamble. **W**HEREAS Canons Lionel Lindsay, Eugène Laflamme, Roméo Guimont; Abbés Ferdinand Vandry, Georges Philippon; the Honourable Cyrille F. Delâge, Superintendent of Public Instruction, and Messrs. François Canac-Marquis, Joseph Aimé Déry, manufacturers, Elzéar Turcotte, and Pierre Célestin Falardeau, merchants, all residing in the city of Quebec, have, by their petition, prayed to be incorporated under the name of *Le Refuge Dom Bosco* for the purpose of working for the moral and social rehabilitation of young boys;

Whereas this work has been in existence for several years and has received the approval of the Roman Catholic religious authorities of the archdiocese of Quebec;

Whereas it is expedient to grant the prayer of the said petitioners;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The said Lionel Lindsay, Eugène Laflamme, Roméo Corporation Guimont, Ferdinand Vandry, Georges Philippon, Cyrille F. <sup>created.</sup> Delâge, François Canac-Marquis, Joseph Aimé Déry, Elzéar Turcotte, Pierre Célestin Falardeau, and all other persons who, under the statutes and by-laws to be adopted, may succeed or join them and become members of the organization, are hereby incorporated under the name of Name. "*Le Refuge Dom Bosco*".

**2.** The corporate seat of the corporation shall be in the Corporate city of Quebec. It shall have perpetual succession and <sup>seat etc.</sup> may appear before the courts.

**3.** The object of the corporation shall be the moral and <sup>Objects, etc.</sup> social rehabilitation of young boys. It shall be subject to the supervision and control of the Roman Catholic Archbishop of Quebec.

**4.** With the consent of the Archbishop of Quebec, the <sup>Powers.</sup> corporation may enjoy all the rights, powers and privileges of ordinary civil corporations, and, in particular, may,—

*a.* acquire, receive, possess, in every manner allowed by law, moveable and immoveable property, provided, however, that the annual revenue from the immoveables owned by the corporation for the purpose of investment shall not exceed one hundred thousand dollars;

*b.* sell, alienate, lease, hypothecate, pledge or otherwise dispose of its property;

*c.* receive donations;

*d.* borrow money on the credit of the corporation by means of bills of exchange, notes, drafts and otherwise;

*e.* exercise also the rights, powers and privileges conferred upon joint stock companies by sub-paragraphs *b*, *c* and *d* of paragraph 1 of article 6056*f* of the Revised Statutes, 1909;

*f.* found, maintain, subsidise or otherwise aid, in the Province of Quebec, novitiates, boarding schools and homes for young boys, night refuges, primary schools of agriculture and schools of arts and trades;

*g.* found, maintain and operate reformatory and industrial schools, houses of detention; receive and detain therein young delinquents and incorrigibles, with the permission of the competent authorities;

*h.* acquire and operate, for the training of apprentices and other purposes, farms and workshops; sell the produce of such farms and the articles manufactured in such workshops; and

*i.* establish perseverance societies, unions, clubs and patronages, and aid them in every way.

**5.** The corporation shall be directed and administered by a council of administration chosen from amongst its members.

By-laws.

**6.** The council of administration may, subject to the approval of the Ordinary of the archdiocese of Quebec, make, amend, repeal and replace such by-laws, not contrary to law, which it may deem expedient in connection with the objects of the corporation, and especially for,—

*a.* the organization, direction, and government of the corporation and of its departments, and the admission and expulsion of members;

*b.* the organization and management of its council of administration, the number of members to compose the same, their qualification, appointment, dismissal and replacement; and

*c.* the management of the affairs of the corporation and the administration of its property.

**7.** The persons mentioned in section 1 of this act shall constitute a provisional council of administration, and shall also have all the powers of the corporation until otherwise provided for according to the by-laws to be adopted.

**8.** In the event of the dissolution of the corporation, its property shall be liquidated in the manner provided by the laws then in force, and, when its debts are paid, the excess, if any, shall be handed over to the Archbishop of Quebec to be utilized in such good works as he may select.

**9.** The corporation shall be bound to transmit, every year, to the Provincial Secretary, a statement of its moveable and immoveable property, a list of its members and a copy of its by-laws.

**10.** This act shall come into force on the day of its sanction.
