

That the inhabitants of Bergeronnes and its environs have expressed their gratitude to the petitioner for the services he has rendered them, especially during the epidemics of diphtheria and more especially during the epidemic of influenza in 1918;

That the petitioner leads a regular and moral life;

That the petitioner followed a complete course of study, with the exception of the last year in philosophy, and that he successfully passed the examination for the degree of Bachelor of Letters;

That he is not one of the class of persons who have neither followed a course nor obtained a diploma;

That in view of the foregoing the College of Physicians and Surgeons of the Province of Quebec has consented to a bill being presented authorizing the petitioner to practise medicine in the Province of Quebec;

Whereas the petitioner has prayed that an act be passed to that effect, and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The College of Physicians and Surgeons of the Coll. of Phys. Province of Quebec is authorized to admit the said J. C. & Surg to admit J.C.L. Lauréat Bussièrès among its members, and to grant him Bussièrès, the necessary license for the practice of medicine in the Province.

## CHAP. 183

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Tésphore Dupuis among its members

[Assented to, 19th of March, 1921]

**W**HEREAS Tésphore Dupuis, of the city and district Preamble.  
of Montreal, doctor of dental surgery, has, by his  
petition, represented:

That in the month of September, 1915, he was enrolled as a student in the school of dental surgery of Laval University, Montreal;

That he followed the courses of this school during the four regular university years, and received the degree of doctor of dental surgery;

That, owing to circumstances beyond his control, he did not present himself for the examinations for admission to the study of dental surgery, before entering the school of dental surgery of Laval University, Montreal;

That in the month of September, 1918, he presented himself before the board of examiners of the College of Dental Surgeons of the Province of Quebec and successfully underwent the examination for admission to the study of dental surgery;

That, considering his studies and qualifications, the Board of Governors of the College of Dental Surgeons of the Province of Quebec have approved of an act being passed to authorize the said College to grant him a license to practise his profession, after an examination;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The College of Dental Surgeons of the Province of Quebec is authorized to admit the said Télesphore Dupuis among its members, and to grant him the necessary license to practise dental surgery in this Province, after examination.

## CHAP. 184

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Louis Orille Geoffrion to the practice of dentistry

*[Assented to, 25th of February, 1921]*

Preamble.

**W**HEREAS Louis Orille Geoffrion, of the city and district of Montreal, doctor of dental surgery, has, by his petition represented:

That he was admitted to and attended the complete course and the clinical studies of dentistry in the school of dental surgery of Laval University, Montreal, where he graduated after the regular examination and received the diploma of Doctor of Dental Surgery on the 10th day of May, 1916;

That, through his duties and experience, he acquired the knowledge and title required for becoming a practician of dental surgery and the skill necessary for the practice of such profession;
