

That, through his duties and experience, he acquired the knowledge and title required for becoming a practician of dental surgery and the skill necessary for the practice of such profession;

That, after obtaining the diploma of Doctor of Dental Surgery, he was prevented from undergoing the examination before the Board of Governors of the College of Dental Surgeons of the Province of Quebec, for the practice of the dental profession, because he did not complete his examination for the admission to study the profession until the 7th of April, 1920, but was regularly admitted on that date, having previously graduated and obtained the diploma of Doctor of Dental Surgery as aforesaid;

That the Board of Governors of the College of Dental Surgeons of the Province of Quebec has consented to the passing of an act to authorize the College of Dental Surgeons of the Province of Quebec to admit the said Léon Leduc among its members and to authorize him to practise the profession of dentist, after the final examination for the practice of such profession;

And whereas he has, by his petition, prayed that an act be passed to that effect, and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Dental Surgeons of the Province of Quebec is authorized to admit Léon Leduc among its members and to grant him the necessary license for the practice of the profession of dentistry in the Province, after the final examinations for the practice of such profession.

CHAP. 188

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Arthur Georges Mongeau among its members

[Assented to, 25th of February, 1921]

Preamble.

WHEREAS Arthur Georges Mongeau, dental surgeon, now domiciled at Longueuil, Province of Quebec, has, by his petition, represented:

That he is thirty-four years of age, has followed a course of studies at the college of the Marist Brothers and obtained

his degree as doctor of dental surgery at the Baltimore Medical College on the 12th of June, 1912;

That, on the 1st of July, 1912, he obtained his license to practise in the State of Rhode Island, and that a similar license was given him on the 17th of March, 1914, to practise dental surgery in the State of Massachusetts;

That moreover he has been a member of the Rhode Island Dental Society since the 10th of June, 1914, and is also a member of the National Dental Association of the United States;

That from the day when he obtained his degree at the Baltimore Medical College, and after obtaining his license for the State of Rhode Island, he practised his profession at Providence, in the State of Rhode Island, for seven years;

That he wishes to come back and live in the Province of Quebec, where he was born, and that he has obtained the consent of the College of Dental Surgeons of the Province of Quebec to the passing of an act authorizing the said college to grant him the necessary license for practising his profession after passing the examination for admission to study and the final examination;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Dental Surgeons of the Province of Coll. of
Quebec is authorized to admit Arthur Georges Mongeau Dent. Surg.
among its members and to grant him the necessary license authorized
for the practice of dental surgery in the Province of Quebec, G. Mongeau. to admit A.
after the examination for admission to practise.
