

his degree as doctor of dental surgery at the Baltimore Medical College on the 12th of June, 1912;

That, on the 1st of July, 1912, he obtained his license to practise in the State of Rhode Island, and that a similar license was given him on the 17th of March, 1914, to practise dental surgery in the State of Massachusetts;

That moreover he has been a member of the Rhode Island Dental Society since the 10th of June, 1914, and is also a member of the National Dental Association of the United States;

That from the day when he obtained his degree at the Baltimore Medical College, and after obtaining his license for the State of Rhode Island, he practised his profession at Providence, in the State of Rhode Island, for seven years;

That he wishes to come back and live in the Province of Quebec, where he was born, and that he has obtained the consent of the College of Dental Surgeons of the Province of Quebec to the passing of an act authorizing the said college to grant him the necessary license for practising his profession after passing the examination for admission to study and the final examination;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The College of Dental Surgeons of the Province of Quebec is authorized to admit Arthur Georges Mongeau among its members and to grant him the necessary license for the practice of dental surgery in the Province of Quebec after the examination for admission to practise. Coll. of Dent. Surg. authorized to admit A. G. Mongeau.

**2.** This act shall come into force on the day of its sanction. Coming into force.

#### C H A P. 189

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit J. Alphonse Thibault, Doctor of Dental Surgery. among its members

[Assented to, 25th of February, 1921]

**W**HEREAS J. Alphonse Thibault, Doctor of Dental Surgery, of the city and district of Montreal, has, by his petition, represented: Preamble.

That during the month of April, 1913, he successfully passed his examination for the diploma of Bachelor of

Letters, being a portion of the examination required for admission to the study of dentistry;

That in the month of September, 1913, he was admitted to follow and did follow a complete course, as well as the clinical studies in connection with dentistry, at the school of Dental Surgery of Laval University, in Montreal, where, after a regular examination, he graduated and obtained the diploma of Doctor of Dental Surgery in the month of May, 1920;

That through his studies and experience he acquired the knowledge and title required for becoming a practitioner in dental surgery and the necessary skill for the exercise of such profession;

That in the month of December, 1915, he voluntarily enlisted in the Canadian expeditionary forces and served from the date of his enlistment until the month of December, 1918;

That he was decorated during the war;

That, owing to irresistible force, it was impossible for him to present himself for that part of the examination for admission to study called the examination in sciences;

That the Board of Governors of the College of Dental Surgeons of the Province of Quebec, on the 13th of November, 1920, gave their approval to the passing of an act authorizing the College of Dental Surgeons of the Province of Quebec to admit the said J. Alphonse Thibault among its members and to authorize him to practise the profession of dentistry after a final examination required by the said board, notwithstanding the fact that he did not pass the examination in sciences;

And whereas he has, by his petition, prayed that an act be passed to that effect, and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:
