An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Ephrem Vinet to the practice of dentistry

[Assented to, 25th of February, 1921]

WHEREAS Ephrem Vinet, of the city and district of Preamble.
Montreal, Doctor of Dental Surgery, has, by his petition, represented that he was admitted to and attended the complete course and the clinical studies of dentistry in the School of Dental Surgery of Laval University, Montreal, where he graduated after the regular examination and received the diploma of Doctor of Dental Surgery on the 10th day of May, 1920;

That through his studies and experience, he acquired the knowledge and title required for becoming a practitioner of dental surgery, and the skill necessary for the practice of such profession;

That after obtaining the diploma of Doctor of Dental Surgery, he was prevented from undergoing the examination before the Board of Dental Surgeons of the Province of Quebec for the practice of the dental profession, because he only completed his examination for admission to study the profession, on the 29th of September, 1920, but was regularly admitted on that date, having previously graduated and obtained the diploma of Doctor of Dental Surgery, as aforesaid;

That the Board of Governors of the College of Dental Surgeons of the Province of Quebec has approved of the passing of an act to authorize the College of Dental Surgeons of the Province of Quebec to admit the said Ephrem Vinet among its members and to authorize him to practise the profession of dentistry, after the final examination for the practice of such profession;

Whereas he has, by his petition, prayed for the passing of an act to that effect, and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Dental Surgeons of the Province of Coll. of
Quebec is hereby authorized to admit the said Ephrem Dent. Surg.
Vinet among its members and to grant him the necessary authorized
license permitting him to practise the profession of den- to admit

CHAP. 191

An Act to change the name of Henry Billingsley Poliwka and others from Poliwka to Billingsley

[Assented to, 25th of February, 1921]

Preamble.

WHEREAS Henry Billingsley Poliwka, of the city of Quebec, merchant, as well personally as in his quality of tutor, duly authorized, to his minor children, to wit:—Wilson Billingsley Poliwka, John Malcolm Poliwka, Henry Kenneth Poliwka and Clifford Thomson Poliwka; Olive Annie Smith Poliwka, wife of the said Henry Billingsley Poliwka; Frederick Poliwka, of the city of Montreal, merchant, as well personally as in his quality of tutor, duly authorized, to his minor children, to wit:—Gordon Billingsley Poliwka, Gertrude Dorothy Poliwka, Laurence Winston Poliwka, Beatrice Mabel Poliwka and George Frederick Poliwka; and Annie Gertrude Dennison Poliwka, wife of the said Frederick Poliwka, have, by their petition, set forth that they are desirous of having their family name, as well as that of the said minor children, changed from Poliwka to Billingsley, so as to obviate and remove the inconvenience and embarrassment to themselves, so frequently resulting from their present name, which, in their opinion, is unsuitable, and have prayed for an act for that purpose, and it is expedient to grant the said prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Change of
name.

1. The family name of the said petitioners and of the said minor children shall be and it is hereby changed from Poliwka to Billingsley, and they shall hereafter be called and known by the latter name; under such name they shall hereafter enjoy, exercise and claim all advantages, benefits, rights and title which without such name they would have been entitled to; all contracts, covenants, agreements and wills made and entered into by them under the name Poliwka shall avail to and be deemed to be entered into by them, by and under the name Bil-
