CHAP. 193

An Act to change the name of William Harvey Green, of the city of St. Lambert, in the county of Chambly, clerk, to that of William Harvey Green Smith

[Assented to, 25th of February, 1921]

WHEREAS William Harvey Green, residing in the city ^{Preamble.} of St. Lambert, in the district of Montreal, clerk, has, by his petition, represented that he desires to have his name changed to that of William Harvey Green Smith, inasmuch as, since the age of six months, he has been brought up by Johnston Smith, also residing in the town of St. Lambert, gentleman, his father and mother having died long ago, that he is known under the name of William Harvey Green Smith, and has carried on all his business under the latter name; that he has prayed for the passing of an act to that effect; and whereas it is expedient to grant the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The said William Harvey Green shall, in future, be ^{Change of} designated and known under the name of William Harvey _{name.} Green Smith, and, under such name, he may in future claim, exercise, and possess all the advantages, benefits, rights and titles which, had not such change of name taken place, he would have had the right to claim, exercise or possess; and all contracts, stipulations, and agreements made by him and in which he may have participated, by and under the name of William Harvey Green, shall avail him and bind him and be deemed to have been made by him by and under the name of William Harvey Green Smith; and all legacies and donations contained in any will, made in his favour under the name of William Harvey Green, shall avail him as if the name of William Harvey Green Smith had been mentioned therein; and likewise, under the latter name, he may recover, have, hold and possess and may receive, as legacies, all the immoveables or personal property and rights of all kinds whatsoever which he may now have, hold or possess, or which he may in future receive by legacy, and may recover, hold and possess the same in as absolute manner and to the same extent as if such change of name had not been effected by this act.

Suits, etc.,

2. If any suits or proceedings in law or equity have been begun by or against the said William Harvey Green Smith under his former name, such suits or such proceedings shall not be affected, and no redress or recovery which may have been the object thereof, shall be prejudiced, on account of such change of name, but they may be continued and carried on to judgment and execution until satisfaction and acquittance are obtained, as if this act had not been passed.

3. All rights and privileges generally of every nature and kind whatsoever which the said William Harvey Green Smith might acquire under this act and those that might be acquired in the future under this act, shall likewise apply to his children and descendants.

CHAP. 194

An Act to regularize the civil status of Joseph Charles Patrice Guy *et al.*

[Assented to, 19th of March, 1921]

Preamble.

WHEREAS Etienne Charles Patrice Guy, notary, of the city of Montreal, has, by his petition, represented:

That he is unmarried and lived publicly, for about twenty years, with Marie Louise Sarrazin, spinster, as his wife, and that from this union were born two children, one of whom was a son, born on the 10th of October, 1912, and the other a daughter, born on the 28th of September, 1914;

That such two children were baptized at the Roman Catholic church of St. Louis de France, in Montreal, the son on the 12th of October, 1912, under the names of Joseph Charles Patrice Guy, son of Etienne Guy, and of Marie Louise Sarrazin, and the daughter, on the 3rd of October, 1914, under the names of Marie Rose Gabrielle Alys Guy, daughter of Etienne Guy and Marie Louise Sarrazin;

That these two children have always been publicly recognized by their father and mother, but that their father delayed having his marriage celebrated owing to the opposition of certain members of his family to the said Marie Louise Sarrazin;
