An Act to amend the act 2 George V, chapter 9, respecting
the changing of the name of the county of Ottawa to
that of Hull

[Assented to, 14th of February, 1920]

HIS MAJESTY, with the advice and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

1. Section 42 of the act 2 George V, chapter 9, is amend-2 Geo. V, c.
ed by replacing the word "Ottawa", in the third line^{9, s. 42, am.}
thereof, by the word "Hull".

2. Section 44 of the act 2 George V, chapter 9, is Id. s. 44,
amended by replacing the word "Ottawa", in the fifth^{am.}
line thereof, by the word "Hull".

3. Section 58 of the act 2 George V, chapter 9, is Id., s. 58,
amended:

a. by replacing the word "Ottawa", in the second line
of the first paragraph thereof, by the word "Hull";

b. by replacing the word "Ottawa", in the third line of
the second paragraph thereof, by the word "Hull".

C H A P. 13

An Act to detach certain lots from the county of Drum-
mond, and to annex them to the county of Arthabaska,
for electoral, judicial, municipal and registration
purposes

[Assented to, 14th of February, 1920]

HIS MAJESTY, with the advice and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

1. The lots of land known and designated as bearing Certain lots
the numbers 23 to 27, inclusive, of ranges XII and XIII detached
of the township of Kingsey, 19 to 27, inclusive, of range^{from the}
county of

Drummond and annexed to the county of Arthabaska. XI, and 19 to 28, inclusive, of range X of the said township of Kingsey, in the county of Drummond, which form part of the parish of Ste. Seraphine, are detached from the said county of Drummond, and annexed to the county of Arthabaska, for electoral, judicial, municipal and registration purposes.

R. S. 67, am. **2.** Paragraphs 2 and 18 of article 67 of the Revised Statutes, 1909, are amended accordingly.

Coming into force. **3.** This act shall come into force on the day of its sanction.

CHAP. 14

An Act respecting the annexation of the township of Decarie to the county of Labelle, for all purposes

[Assented to, 14th of February, 1920]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Township of Decarie annexed to county of Labelle. **1.** The township of Decarie, in the county of Montcalm, shall be detached from that county and annexed to the county of Labelle, for all purposes whatsoever.

S., 67, am. **2.** Paragraph 26a of article 67 of the Revised Statutes, 1909, as enacted by section 8 of the act 2 George V, chapter 9; paragraph 30a of article 74 of the said statutes, as enacted by paragraph d of the annex to section 2 of the act 7 George V, chapter 13; and paragraph 29a of article 75 of the said statutes, as enacted by paragraph d of the annex to section 6 of the act 7 George V, chapter 13, are amended accordingly.

Coming into force. **3.** This act shall come into force on the day of its sanction.
