CHAP. 19

An Act to amend the Revised Statutes, 1909, respecting
the Agent-General for the Province in the
United Kingdom

[Assented to, 14th of February, 1920]

HIS MAJESTY, with the advice and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

1. Article 689 of the Revised Statutes, 1909, as amend- ^{R. S., 689,}

in the second line thereof, the words: "to the Agent-Gen-
eral for the Province in the United Kingdom,".

2. Section 6 of the act 7 George V, chapter 16, as ^{7 Geo. V., c.}
amended by the acts 9 George V, chapter 16, section 2, and ^{16, s. 2, am.}

10 George V, chapter 20, section 1, is further amended by inserting therein, after the figures: "1909", in the third line of the second paragraph thereof, the words: "the Agent-General for the Province in the United Kingdom,".

R. S., 689*a*, am. **3.** Article 689*a* of the Revised Statutes, 1909, as enacted by the act 9 George V, chapter 16, section 4, and amended by the act 10 George V, chapter 20, section 2, is further amended by inserting therein, after the first paragraph thereof, the following:

"The Agent-General for the Province in the United Kingdom must pay, with compound interest, to the Provincial Treasurer, by annual instalments distributed over a period of ten years from the first of July, 1920, a sum equal to the total amount which should have been retained out of his salary if this act had been in force on the 7th of August, 1911."

An Act to amend the Revised Statutes, 1909, respecting pensions of public officers
