3. The following article is inserted in the Revised Statutes, 1909, after article 1987 thereof, as amended by the act 8 George V, chapter 34, section 5:

Penalty.

"1987*a*. If, after such date, an association has neglected or refused to send in such statement, it shall be liable to a penalty of five dollars for every day it continues to be in default; and any director or manager of the association who authorizes or knowingly and deliberately permits such default shall be liable to the same penalty."

CHAP. 26

An Act to amend the Revised Statutes, 1909, respecting
the manufacture of dairy products

[Assented to, 14th of February, 1920]

HIS MAJESTY, with the advice and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

1. Article 2029 of the Revised Statutes, 1909, is amended:

a. by striking out the words: "by and in the name of the collector of provincial revenue of the district in which the offence was committed", in the second, third and fourth lines thereof;

b. by striking out the second paragraph thereof.

am.

2. Article 2031*d* of the said statutes, as enacted by the act 1 George V (1st session), chapter 16, section 1, and amended by the act 7 George V, chapter 24, section 1, is again amended:

a. by inserting therein, after the word: "entered", in the fifth line thereof, the words: "in his name".

b. by striking out the second paragraph thereof.

3. Article 2031*f* of the said statutes, as enacted by the act 1 George V (1st session), chapter 16, section 1, is amended by adding thereto, at the end of the second paragraph thereof, the following words: "Such permit may at any time be revoked by the Minister, on the recommendation of one of the inspectors general, by notice given by registered letter to the holder of the permit".

4. Article 2031*o* of the said statutes, as enacted by the Id., 2031*o*, act 5 George V, chapter 31, section 10, is amended: ^{am.}

a. by inserting therein, after the word: "each", in the fourth line of the first paragraph thereof, the words: "owner or lessee of a";

b. by replacing the word: "June", in the second line of the second paragraph thereof, by the word: "July".

5. Article 2031*p* of the said statutes, as enacted by the Id., 2031*p*, act 5 George V, chapter 31, section 10, is amended by ^{am.} inserting therein, after the word: "liable", in the fourth line thereof, the words: "at the instance of any person,".

CHAP. 27.

An Act to amend the Revised Statutes, 1909, respecting the protection of bees

[Assented to, 14th of February, 1920]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Article 2041*b* of the Revised Statutes, 1909, as enacted by section 1 of the act 1 George V (2nd session), chapter 22, is replaced by the following: ^{R. S., 2041*b*, replaced.}

"2041*b*. Every person found guilty of an offence ^{Penalty on} against article 2041*a* shall, on summary conviction thereof ^{conviction.} before a magistrate having jurisdiction at the place where the offence was committed, or on penal action before the Circuit Court having jurisdiction, be liable, for each offence, to a fine of not less than five nor more than fifty dollars, and costs, and, in default of payment of such fine and costs, to imprisonment for not more than forty days."

2. This act shall come into force on the day of its ^{Coming} sanction. _{into force.}
