d. paying the charges and disbursements incurred for the passing of this act.

2. This act shall authorize and empower the said school commissioners to issue, by a mere resolution, bonds or debentures to an amount not exceeding four hundred thousand dollars for the above purposes, for a term not exceeding forty years, and bearing interest at a rate not exceeding six per cent per annum, and with a sinking-fund of not more than one per cent, to be applied to the repayment of the loan. Bond issue on mere resolution.

3. With a view to facilitate the loan authorized by this act the School Commissioners for the municipality of the city of Outremont in the county of Westmount are expressly authorized to issue, if they deem it advisable, bonds of various denominations, say of one hundred dollars, of two hundred dollars, of five hundred dollars or of one thousand dollars each, and, in such case, to number them from one, inclusive, up to the number to be determined by the number of the bonds. Denominations of bonds.

4. The bonds and interest coupons attached to the same shall be payable at such place or places as may be indicated on their face and be mentioned in a resolution of the commissioners to that effect. Payment of principal and interest.

5. This act shall come into force on the day of its sanction. Coming into force.

CHAP. 42

An Act to amend the charter of the Montreal school for higher commercial studies

[Assented to, 14th of February, 1920]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:
