An Act to amend the act to assist in the construction of dwelling-houses in cities, towns and villages

[Assented to, 14th of February, 1920]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The act 4 George V, chapter 47, is amended by 4 Geo. V, c. inserting therein, after section 2 thereof, the following ^{47, s. 2a, enacted.} section:

"2a. A company incorporated under this act may sell ^{Council em-} one or more of its immoveables, with the consent of the ^{powered to} municipal council and upon such conditions as may be ^{sell im-} imposed by the Lieutenant-Governor in Council upon the ^{moveables} recommendation of the Minister of Municipal Affairs." ^{under} ^{certain con-}

2. Section 4 of the said act is amended:

a. by striking out the words: "or the resolution", in the first line thereof;

b. by striking out the words: "or resolution", in the fifth line thereof; and

c. by adding thereto, at the end thereof, the words: "and by the Lieutenant-Governor in Council".

3. Section 5 of the said act is amended by striking out ^{Id., s. 5, am.} the words: "or resolution", in the first line thereof.

4. Section 6 of the said act is amended;

a. by striking out the words: "or resolution", in the ^{Id., s. 6, am.} first line of the first paragraph thereof;

b. by striking out the words: "or resolution", in the second line of the second paragraph thereof.

5. Section 7 of the said act is amended by striking out the ^{Id., s. 7, am.} words: "or resolution", in the second and third lines thereof.

6. Section 10 of the said act is amended:

a. by striking out the words: "or of the Lieutenant- ^{Id., s. 10,} Governor, alone or in council", in the eighth and ninth ^{am.} lines thereof;

b. by adding thereto the following paragraph:

Approval of "Any by-law ordering or authorizing a loan under this
loan by-law, section must first be approved by the Lieutenant-Governor

Id., s. 27, am. **7.** Section 27 of the said act is amended by inserting therein, after the word: "approval", in the third line thereof, the words: "but which must be approved by the Lieutenant-Governor in Council".

Coming into force. **8.** This act shall come into force on the day of its sanction.

CHAP. 72

An Act respecting certain companies and corporations

[Assented to, 14th of February, 1920]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

R. S., 5957 to 6090, etc., replaced. **1.** Sections I and II of chapter third of title eleventh of the Revised Statutes, 1909, (articles 5957 to 6090 inclusive, and the forms A, B, C, D and E, following article 6090 of such statutes, as well as the amendments from time to time made thereto) are replaced as follows:

"SECTION I

" CERTAIN COMPANIES AND CORPORATIONS

SHORT TITLE AND GENERAL PROVISIONS

Short title. **"5957.** This section may be cited as "The Quebec Companies' Act, 1920".

Substitute to sign for Lt.-Gov. **"5957a.** The Lieutenant-Governor may appoint under his hand and seal, for such term as he thinks fit, a competent person to sign any document that he is authorized to sign under any provision of this section. The writing by which such appointment is made must be filed in the department of the Provincial Secretary and Registrar, to form part of the archives of that department.
