

hospital, from aged persons to young orphans or abandoned children; see to the instruction and education of the young; establish and maintain new hospitals in any place within the Province of Quebec, and, for educational purposes, establish trades, agricultural industries, also household science or other schools, and sell the proceeds thereof for the benefit of its work.

6. The persons above mentioned shall constitute a Provisional provisional board of management to exercise the powers board of management of the corporation until otherwise provided in accordance with the by-laws which may be adopted.

7. The corporation shall every year transmit to the Provincial Secretary a statement of its moveable and to Prov. immovable property and the names of its officers, as well Sec. as a copy of its by-laws.

8. This act shall come into force on the day of its Coming sanction. into force.

CHAP. 139

An Act to incorporate The Wales Home

[Assented to, 14th of February, 1920]

WHEREAS on the 25th day of September, 1916, the Preamble.
late Horace P. Wales of the township of Cleveland, in the Province of Quebec, made his last will and testament, by which he bequeathed all the rest, residue and remainder of his estate to the Congregational, Presbyterian, Methodist and Anglican clergymen of Melbourne and Richmond, or to their successors, in trust, to be the foundation of a Protestant old people's home;

Whereas it is necessary and advisable, in order to secure permanent and effective management of the said trust, and of the old people's home created thereby, that a corporate body be formed;

Whereas the persons hereinafter mentioned have by their petition prayed that the legislative provisions set forth below be enacted, and it is expedient to grant the said prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Corpor-
tion
created.

1. The Reverend William MacMillan, Reverend Telesphore Roy and the Reverend James F. Belford, all of the town of Richmond, and the Reverend Galen H. Craik of the township of Melbourne in the Province of Quebec, clergymen; Marcus G. Crombie, gentleman, James Smillie, gentleman, Ernest L. Hall, merchant, Albert S. Raimback, banker, George J. Alexander, insurance agent, William J. Ewing, registrar, Percy C. Duboyce, notary public, Arthur V. Glassey, secretary-treasurer, William E. McIver, post-master, all of the town of Richmond, in said Province; Edward C. Atkinson, merchant, Honorable Walter G. Mitchell, Provincial Treasurer, and Robert G. Dunbar, farmer, all of the township of Melbourne, in said Province; Thomas Torrance, lumber manufacturer, of the township of Melbourne; Stephen Smith, farmer, of the township of Cleveland, and Theodore Tanner, accountant, of the town of Richmond, in said Province, and also the persons who will become members of the corporation, are incorporated under the name of "The Wales Home", and designated in the present act as the corporation.

Name.

Vesting of
property,
etc.

2. The said corporation is hereby vested with the proprietorship of all the property mentioned in clause fourthly of the last will and testament of the late Horace P. Wales, in the place and stead of the Congregational, Presbyterian, Methodist and Anglican clergymen of Melbourn and Richmond, and shall enter into possession of, and carry on and administer the same.

Objects.

3. The intents and purposes for which this corporation is hereby created are declared to be :

a. the admission, care of and maintenance of old people who are Protestants, and who are desirous of being admitted to, maintained and cared for in the said home, the whole in accordance with the regulations provided for by the by-laws to be enacted, and subject to such limitations and charges as may hereinafter be determined on and settled by such by-laws;

b. the care of such people as may fall sick while in the home and providing for them such nursing and care only as may be available.

General
corporate
powers.

4. The corporation shall have a perpetual succession and may contract and be contracted with, sue and be sued, plead and be impleaded in all courts and places whatsoever in this Province.

Powers.

5. The corporation shall have the right to take, hold

and possess all real or immoveable property, and all money or moveable property which may legally have been or may be hereafter given, granted, purchased, appropriated or devised or bequeathed in any manner whatever, in favour of the said Wales Home, and upon such terms and conditions as the donor or testator thereof may impose, provided always that the immoveable holdings for permanent purposes by the corporation shall not exceed the annual value of the sum of twenty thousand dollars.

6. The corporation shall have the power to sell and convey, let or lease any property appertaining to it, as may be deemed advisable upon a resolution passed by the board of governors, provided always that all money from time to time to be received by it on account of real estate, by it alienated or to be alienated, shall be dealt with as capital only, and not income, and shall be promptly invested in the best manner possible.

7. The corporation shall be composed of life members and ordinary members. Classes of members.

8. The following shall be life members:

a. the Congregational, Presbyterian, Methodist and Anglican clergymen of Melbourne and Richmond, namely, the Rev. William MacMillan, Rev. T. Roy, Rev. J. P. Belford and the Rev. G. H. Craik, and their successors in office; should it come to pass that there should be no Congregational, Presbyterian, Methodist or Anglican clergymen at Melbourne or Richmond, then a clergyman of such Congregational, Presbyterian, Methodist or Anglican denomination in the county of Richmond shall be chosen by the board to be a life member, to represent each of such churches as may no longer exist in said Richmond or Melbourne, or no longer have a clergyman in said Richmond or Melbourne;

Life members.

b. all donors of one hundred dollars and upwards.

9. The following shall be ordinary members: all subscribers to the funds of the corporation of five dollars or more per year and less than one hundred dollars per year. Ordinary members.

10. The affairs of the corporation shall be under the control and management of a board of governors. Board of Governors.

11. The clergymen of the Congregational, Presbyterian, Methodist and Anglican denominations of Richmond and Melbourne, as the case may be, as provided by section Composition of board.

8, and their successors, shall always be on the board of governors. The remaining governors shall be elected annually from among the persons qualified under the terms of section 12, which number, however, may be increased by by-law of the corporation, as may be deemed necessary or expedient.

Qualifications for governor.

12. All life members, and all ordinary members who are donors of twenty-five dollars or upwards per year and not in arrears for any such subscriptions, shall be eligible as governors, provided always that such persons shall at the time of their election be connected with one of the Protestant denominations in the Province of Quebec.

Tenure of office.

13. Except as regards the clergymen above mentioned, the governors shall hold office for one year or until their successors are appointed.

Powers of board.

14. The governors shall have full power to manage and administer the affairs of the corporation, which corporation may from time to time make by-laws providing for the officers of the corporation and for the management of all matters in connection with its administration.

Head office.

15. The head office of the corporation shall be at the town of Richmond in the Province of Quebec.

Statement for Lt. Gov. in C.

16. The corporation shall transmit to the Lieutenant-Governor in Council, when thereunto required by the Provincial Secretary, a detailed statement of its movable and immovable property, the names of its officers, and a certified copy of its rules and regulations.

Coming into force.

17. This act shall come into force on the day of its sanction.
