1. The testamentary executors and trustees of the will of the late McDuff Lamb are hereby authorized, out of the revenues of the estate, so long as they be sufficient after payment of all expenses of administration so to do, to pay to the said Martha Jane Wakefield an annual allowance of six thousand dollars in lieu of the two thousand five hundred dollars specified in the will of the late McDuff Lamb executed before R. A. Dunton and colleague, notaries, on the second of May, 1905, until the eldest child, McDuff Wakefield Lamb, attains the age of twenty-one years, when the said annual allowance shall be reduced, and after the next child attains the age of majority the said allowance shall further be reduced, and so on, the whole according to the terms of the said will.

To pay
charges on
property.

The said trustees are hereby authorized to pay all charges on the said property (including the interest on said fourteen thousand dollars), now occupied by the said Martha Jane Wakefield, in order to give her the free occupation, use and enjoyment of the said property as a residence in Montreal as provided by said will, so long as she occupies the same.

2. The costs and disbursements incurred in connection with the passing of this act shall be paid by the estate.

3. This act shall come into force on the day of its sanction.

CHAP. 153

An Act respecting the estate of the late Louis Herménégilde Hébert

[Assented to, 14th of February, 1920]

Preamble.

WHEREAS Dame Elodie Gauthier, of the city and district of Montreal, widow of Louis Herménégilde Hébert, in his lifetime of the same place, wholesale merchant, both personally and in her capacity of tutrix to her minor child Magdeleine Hébert, has, by her petition, represented:

That, by his will dated the 31st of August, 1907, made at Montreal before Messrs. Henri P. Pépin and René Leroux, notaries, and by a codicil to the said will made before the same notaries at Montreal, on the 13th of

December, 1907, the said late Louis Herménégilde Hébert bequeathed the whole of his property to his daughter Magdeleine without any exception, one-half in full ownership and the other half as institute in a substitution, subject to the charge of giving, at her death, the said one-half of her property to her lawful children or descendants according to the order of succession; the said Magdeleine Hébert to receive, however, until her majority, the revenues of one-half the property bequeathed to her in full ownership;

That, by the same will and codicil, the said late Louis Herménégilde Hébert bequeathed to the petitioner, out of the revenues of his property, a monthly life rent of two hundred dollars so long as she remained a widow, or of one hundred dollars in case she married again;

That the said Louis Herménégilde Hébert died at Montreal on the 26th of January, 1908;

That by the act 7 George V, chapter 125, it was enacted, after having heard *La Société d'Administration Générale*, the testamentary executor, that the rent of the said Magdeleine Hébert during her minority should be two thousand four hundred dollars per annum;

That the revenues from the said estate are very considerable and are increasing from year to year;

That the rent of the said Magdeleine Hébert is entirely out of proportion to such revenues;

That such rent is altogether insufficient for the maintenance and education of the said Magdeleine Hébert, in view chiefly of the increase in the cost of living since the passing of the said act 7 George V, chapter 125;

That the rent bequeathed to the petitioner personally is also altogether insufficient for providing for her needs, in view of the increase in the cost of living since the death of the said testator;

And whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Section 1 of the act 7 George V, chapter 125, is replaced by the following:

"1. The testamentary executor appointed by the will of the said late Louis Herménégilde Hébert shall pay to the said Magdeleine Hébert, until she has attained her majority, an annual sum of six thousand dollars, to replace the annual rent fixed by the will of the late Louis Herménégilde Hébert.

2. The said testamentary executor shall pay the said Dame Elodie Gauthier, widow of Louis Herménégilde Hébert, a monthly life rent of four hundred dollars so long as she remains a widow, or of two hundred dollars in case she marries again.

3. The disbursements of the petitioner and of the testamentary executor, as well as the disbursements and fees of their attorneys incurred for the passing of this act, shall be a charge upon the capital of the estate, and be paid by the testamentary executor *La Société d'Administration Générale*.

CHAP. 154

An Act respecting the estate of Joseph Gareau

[Assented to, 14th of February, 1920]

Preamble.

WHEREAS Antoine Rodolphe Ranger, insurance broker, of the city of Montreal, in his capacity of testamentary executor and trustee of the late Joseph Gareau under the terms of the will of the latter made before Mtre. Edouard Biron, notary, on the 19th July, 1909, the Misses Marie-Anne Martel, Antoinette Martel, Bernadette Martel, all of full age of majority, residing at Saint-Lin-des-Laurentides, and Joseph Martel, of the parish of Saint-Lin-des-Laurentides, in his capacity of tutor to his minor children; Josaphat Martel, Lucien Martel, Emmanuel Martel, Cécile Martel, Narcisse Martel and Gabriel Martel, issue of his marriage with the late Dame Christiana Gareau, all legatees by universal title, under the terms of the said will of the late Joseph Gareau; and Dame Bernadette Payette, of the city of Montreal, widow of the said Joseph Gareau, legatee by particular title under the terms of a codicil of the late Joseph Gareau, under date of the 7th of April, 1918, have, by their petition, represented:
