

C H A P. 163

An Act to authorize the Bar of the Province of Quebec to admit Percy Flynn to the practice of the legal profession, after examination

[Assented to, 14th of February, 1920]

Preamble.

WHEREAS Percy Flynn, law student, has by his petition represented that he is twenty-nine years old, having been born in Quebec, on the 13th of December, 1889;

That in September, 1910, he matriculated at Laval University, in Quebec, regularly followed all the courses of the law faculty during three years, successfully passed all the term examinations, and obtained the diploma of Bachelor of Laws;

That during the three years of the law course, he was attached to the law office of practising advocates, and did the usual work of a law student;

That in May, 1915, he was compelled to interrupt his studies to enlist in the Canadian Expeditionary Force, and since then he has been in active service in the Canadian Expeditionary Force in the war between England and Germany, and never had any other employment nor any other occupation, and that he is still on active service, not having yet been demobilized;

That he was admitted to the study of law on the 8th of July, 1919;

That he wishes to become a member of the Bar of the Province of Quebec and to be admitted after the regular examinations, and to have the right to begin practising his profession immediately;

That at a meeting of the general Council of the Bar of the Province of Quebec, on the 23rd of October, 1919, a resolution was passed, approving the passing of an act to allow the petitioner to present himself at the regular examination for the practice of law, to have his clerkship count as beginning in the month of September, 1910, and, immediately after passing the examination for admission to practice, to begin to practise his profession;

Whereas the said Percy Flynn has prayed that an act be passed for the purposes above mentioned, and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Bar may

1. The Bar of the Province of Quebec is authorized to

allow the clerkship of Percy Flynn to count from the month of September, 1910, to allow him to undergo the regular examination for admission to practise law and to allow him to practise law immediately after having successfully passed the said examination. admit Percy Flynn to practise after examination.

2. This act shall come into force on the day of its sanction. Coming into force.

C H A P. 164

An Act to authorize the Bar of the Province of Quebec to admit Charles Montminy to the practice of law, after examination

[Assented to, 14th of February, 1920]

WHEREAS Charles Montminy, law student, has by petition represented: Preamble.

That he is a British subject by birth, having been born in Quebec, on the 5th day of May, 1891;

That he followed the classical course of the Quebec Seminary;

That he followed the courses of Laval University for three years;

That he studied under indenture in the office of Mr. G. G. Stuart, advocate, of Quebec, counting from November, 1910;

That he was admitted to the study of law, in sciences, on the 9th of July, 1914;

That he had, on the 5th day of July, 1915, given his notice and made his deposit for the purpose of completing his examination for admission to the study of law by undergoing the examination in letters, but he was prevented from doing so in July, 1915, because he was called to military service on the 21st of June, 1915, upon his voluntary enlistment in His Majesty's troops for the war just ended;

That he completed his regular admission to the study of law by successfully passing the examination in letters on the 8th of July, 1919;

That on account of his military service overseas he cannot present himself for the examination for admission to the practice of law until July, 1922, which will make him lose considerable time and cause him irreparable damage;
