

Quebec has approved the passing of an act to allow the petitioner to be admitted to practice immediately after successfully undergoing the regular and ordinary examination;

Whereas the said Charles Montminy has prayed for the passing of an act for the aforesaid purposes, and it is expedient to grant the request to that effect contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Bar authorized to admit C. Montminy to practise after examination. Coming into force.

1. The Bar of the Province of Quebec is authorized to admit Charles Montminy to the practice of law immediately after the regular and ordinary examination for admission to the practice of the legal profession.

2. This act shall come into force on the day of its sanction.

CHAP. 165

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Z. Armour Côté to the practice of dentistry

[Assented to, 14th of February, 1920]

Preamble.

WHEREAS Z. Armour Côté, of the city and district of Montreal, doctor of dental surgery, was admitted to follow, and has followed a complete course of clinical studies in dentistry at the school of Dental Surgery of Laval University at Montreal, where, after a regular examination, he graduated and received the diploma of doctor of dental surgery on the 3rd May 1918;

Whereas, through such studies and his experience, the has acquired the knowledge and title required for practising dental surgery and the necessary competence for the exercise of that profession;

Whereas, since he obtained the said diploma of doctor of dental surgery, he has been prevented from undergoing the examination before the Board of Governors of the College of Dental Surgeons of the Province of Quebec for practising the profession of dentistry because he completed only on the 10th September 1919, his examination for admission to the study of that profession, but was regularly admitted at that date, after having previously

graduated and obtained the diploma of doctor of dental surgery as aforesaid;

Whereas the Board of Governors of the College of Dental Surgeons of the Province of Quebec has given its approval to the passing of an act authorizing the College of Dental Surgeons of the Province of Quebec to admit the said Z. Armour Côté amongst its members and to authorize him to practise the profession of dentistry after a final examination for the practice of that profession;

Whereas he has, by his petition, prayed that an act be passed to that effect, and it is expedient to grant the prayer of the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Dental Surgeons of the Province of Coll. Dental Quebec is hereby authorized to admit the said Z. Armour Surgeons Côté amongst its members and to grant him the necessary Z. A. Côté may admit license to practise the profession of dentist in this to practise Province after a final examination for admission to the after exam- practice of that profession. ination.

CHAP. 166

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Daniel Prescott Mowry to the practice of dentistry

WHEREAS Daniel Prescott Mowry, of the city and dis- Preamble. trict of Montreal, doctor of dental surgery, has been admitted to follow and has followed a complete course and taken clinical training in dentistry in the school of dental surgery of McGill University, Montreal, from which, after due examination, he has graduated and received the diploma of doctor of dental surgery on the 11th day of May, 1917;

Whereas he has, in consequence of his studies and experience, all the knowledge and title required of a practising dental surgeon, and the necessary competence to practise as such;
