

C H A P. 6

An Act to amend the Good Roads Act, 1912

[Assented to, 4th of March, 1919]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The following section is inserted in the act 3 George V, chapter 21, after section 10 thereof: 3 Geo. V, c. 21, s. 10a, enacted.

“**10a.** When a municipality has passed the by-law mentioned in section 2, to the satisfaction of the Lieutenant-Governor in Council, it may, notwithstanding any provision of the general or special acts by which it is governed, borrow, from time to time, on notes, on a mere resolution, the money necessary to carry out, under the direction of the Minister of Roads, any of the work ordered by the by-law; provided that the total amount of the loans it contracts under this section shall not exceed the amount fixed by the Roads Department under paragraph *b* of section 2 as that which may be supplied by the Government for the performance of the work mentioned in such by-law. Power of municipality to borrow.”

The rate of interest on any loan contracted under this section shall not be higher than seven per cent per annum.” Rate of interest.

2. This act shall come into force on the day of its sanction. Coming into force.

C H A P. 7

An Act to amend the act 7 George V, chapter 5, granting certain powers to the Quebec Streams Commission relating to the storing of the waters of the Ste. Anne and Savane rivers

[Assented to, 17th of March, 1919]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Section 1 of the act 7 George V, chapter 5, as amended by the act 8 George V, chapter 16, section 1, is again 7 Geo. V, c. 5, s. 1, am.

amended by inserting therein, after the word: "Savane", in the eighth line thereof, the words: "in the said river Ste. Anne or any other of its tributaries".

Id., s. 5, am. **2.** Section 5 of the act 7 George V, chapter 5, as amended by the act 8 George V, chapter 16, section 2, is again amended by replacing the words: "two hundred thousand dollars", in the fifth and sixth lines thereof, by the words: "three hundred thousand dollars".

Coming into force. **3.** This act shall come into force on the day of its sanction.

C H A P. 8

An Act to amend the act 5 George V, chapter 9, providing for the construction and maintenance of an iron bridge, free to traffic, over the Richelieu river, between the towns of St-Johns and Iberville

[Assented to, 17th of March, 1919]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

5 Geo. V, c. 9, s. 10, am. **1.** Section 10 of the act 5 George V, chapter 9, is amended by replacing the words: "one-third to the town of Iberville", in the last two lines thereof, by the words: "one-sixth to the town of Iberville and one-sixth to the county of Iberville".

Id., s. 15n, enacted. **2.** The act 5 George V, chapter 9, is amended by inserting therein, after section 15 thereof, the following section:

County of Iberville. **"15a.** The county of Iberville shall exercise, jointly with the towns of St. Johns and Iberville, the various powers conferred upon them by sections 12, 13, 14 and 15 of this act."

Coming into force. **3.** This act shall come into force on the day of its sanction.
