

## C H A P. 39

An Act to amend the act 46 Victoria, chapter 21, respecting public instruction, in so far as respects the town of Richmond

[Assented to, 17th of March 1919]

Preamble.

**W**HEREAS the Board of Roman Catholic School Commissioners of the town of Richmond and the Board of Protestant School Commissioners of the town of Richmond have, by their petition, represented that the act 46 Victoria, chapter 21, as amended by the act 47 Victoria, chapter 29, should be further amended in such a way as to bring such law more in conformity with the general laws of the Province governing public instruction, and also to enact provisions respecting the mode of collecting taxes for school purposes, and have prayed for the passing of an act to that effect;

And whereas it is expedient to grant such prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Sections 5, 7, 8, 11, 12, 13, 15, 16, 18, 19, 20, 21, 22, 23, 24, 27, 29, 30, 31, 32, 33, 34, 35, 37, 38, 39, 40 and 43 of the act 46 Victoria, chapter 21, and sections 9, 10, 14, 17, 28 and 36 of the same act, as amended by the act 47 Victoria, chapter 29, are repealed.

**2.** The following section is inserted in the act 46 Victoria, chapter 21, after section 4 thereof, as replaced by section 2 of the act 47 Victoria, chapter 29:

Power to  
make tem-

loans.

**4a.** The two said boards of commissioners or either board, may from time to time make temporary loans, by promissory note or otherwise, upon a resolution to that effect by the board or boards interested, without it being necessary to obtain the approval of the ratepayers; but such loans must at no time exceed one thousand dollars."

**3.** Section 25 of the act 46 Victoria, chapter 21, is replaced by the following:

Payment of  
taxes to  
school  
boards.

**25.** The taxes for school purposes shall be collected by the municipal corporation of the town of Richmond, and such sum shall be paid by such corporation to the secretary-treasurer of each board of school commissioners in four equal payments, which shall fall due quarterly on

the first days of July, October, January and April of each year, respectively."

4. This act shall come into force on the first day of July, 1919. Coming into force.

## C H A P. 40

### An Act to incorporate the Sherbrooke Technical School

[Assented to, 4th of March, 1919]

**W**HEREAS it is desirable for the needs of trade and industry in this Province, to prepare, by means of practical and technical studies, young men who intend to devote themselves to industrial careers, and, by means of adequate instruction capable of training them in a practical manner, to develop in them a sufficient knowledge of mechanical trades and of industry generally; Preamble.

Whereas a technical school in Sherbrooke, founded for the object aforesaid, would turn out manufacturers and workmen possessing sufficient theoretical knowledge and trained in practical shop work;

Whereas it is expedient to constitute a corporation for the purpose of assuring to such school all the advantages that may be secured for it by the Government of this Province, by the city of Sherbrooke and by private individuals;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. A technical industrial school is incorporated in the city of Sherbrooke under the name of "The Sherbrooke Technical School". Corporation created.

The corporation shall consist of:

a. Two delegates appointed by the council of the city of Sherbrooke; Members.

b. Three delegates appointed by the Lieutenant-Governor in Council.

The principal of the school, after his appointment under section 10, shall be *ex officio* a member of the corporation. Principal of school.

2. Such delegates shall be appointed for three years. Their services shall be gratuitous. Term of office.
