

## C H A P. 78

An Act to amend article 61 of the Code of Civil Procedure  
respecting the district magistrate's court

[Assented to, 4th of March, 1919]

**H**IS MAJESTY, with the advice and consent of the  
Legislative Council and of the Legislative Assembly  
of Quebec, enacts as follows:

C. C. P., 61, amended. **1.** Article 61 of the Code of Civil Procedure, as amended by the acts 3 Edward VII, chapters 51 and 52; 6 Edward VII, chapter 42, section 1; 9 Edward VII, chapter 74, section 1, 1 George V (1st session), chapter 8, section 14, paragraph M, 2 George V, chapter 9, section 77; and 9 George V, chapter 12, section 14, is further amended by inserting therein, after the words: "district of Montcalm", in the amendment inserted by the act 1 George V (1st session), chapter 8, section 14, paragraph M, in the third line of paragraph 1 of the said article, the words: "in the county of Lake St. John".

Coming into force. **2.** This act shall come into force on the day of its sanction.

## C H A P. 79

An Act to amend articles 639, 717, 1029, 1048, 1069 and  
1352 of the Code of Civil Procedure

[Assented to, 17th of March, 1919]

**H**IS MAJESTY, with the advice and consent of the  
Legislative Council and of the Legislative Assembly  
of Quebec, enacts as follows:

C. C. P., art. 639, am. **1.** Article 639 of the Code of Civil Procedure, as amended by the acts 6 Edward VII, chapter 42, section 2; 1 George V (1st session), chapter 44, section 1; and 2 George V, chapter 49, section 2, is further amended:

a. by inserting therein, after the word: "Sherbrooke," in the eighth line thereof, the word: "Hull";

b. by replacing the words: "or Sorel or in the town of", in the eighth line thereof, by the words: "Sorel and".

Id. art. 717, am. **2.** Article 717 of the said code, as amended by the acts

6 Edward VII, chapter 42, section 3, and 1 George V (1st session), chapter 44, section 2, is further amended:

*a.* by inserting therein, after the word "Sherbrooke", in the second and tenth lines of paragraph 1 thereof, the word "Hull";

*b.* by replacing the words: "or Sorel or in the town of", in the second and third, and in the tenth line thereof, by the words: "Sorel or".

**3.** Article 1029 of the said code, as amended by the acts *Id.*, art. 6 Edward VII, chapter 42, section 4, and 1 George V (1st session), chapter 44, section 3, is further amended:

*a.* by inserting therein, after the word "Sherbrooke", in the second line of the second paragraph thereof, the word "Hull";

*b.* by replacing the words: "and Sorel and in the town of," in the second and third lines of the said second paragraph thereof, by the words: "Sorel and".

**4.** Article 1048 of the said code, as amended by the acts *Id.*, art. 6 Edward VII, chapter 42, section 6, and 1 George V (1st session), chapter 44, section 4, is further amended:

*a.* by inserting therein, after the word: "Sherbrooke", in the sixth line of paragraph 2 thereof, the word: "Hull";

*b.* by replacing the words: "or Sorel or in the town of", in the seventh line of paragraph 2 thereof, by the words: "Sorel or".

**5.** Article 1069 of the said code, as amended by the acts *Id.*, art. 6 Edward VII, chapter 42, section 7, and 1 George V (1st session), chapter 44, section 5, is further amended;

*a.* by inserting therein, after the word: "Sherbrooke", in the sixth line of paragraph 2 thereof, the word: "Hull";

*b.* by replacing the words: "or Sorel or in the town of", in the sixth and seventh lines of paragraph 2 thereof, by the words: "Sorel or".

**6.** Article 1352 of the said code, as amended by the acts *Id.*, art. 6 Edward VII, chapter 42, section 8, and 1 George V (1st session), chapter 44, section 6, is further amended:

*a.* by inserting therein, after the word: "Sherbrooke" in the seventh line of paragraph 1 thereof, the word: "Hull";

*b.* by replacing the words: "or Sorel or in the town of", in the seventh and eighth lines of paragraph 1 thereof, by the words: "Sorel or".
