“**2662.** In order to be entitled to vote at an election of school commissioners of the city of Hull, a person must be the owner of immoveable property, or be owner merely of a building erected on a lot of land belonging to somebody else, and be entered as such on the valuation roll.

In a municipality where there is a corporation of school trustees, the persons forming part of the minority who are declared dissentients cannot vote at an election of school commissioners, and the persons belonging to the majority cannot vote for school trustees.”

CHAP. 97

An Act to amend the charter of the city of Sorel

[Assented to, 17th of March, 1919]

Preamble.

WHEREAS the city of Sorel has, by its petition, represented that it is in the interest of the ratepayers and necessary for the proper administration of its affairs that its charter, the act 52 Victoria, chapter 80, and the amendments thereto, be amended for the purpose of allowing the city to make certain loans; and

Whereas it is expedient to grant its prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The following section is added after section 595 of the act 52 Victoria, chapter 80, as replaced by section 8 of the act 62 Victoria, chapter 60:

“**595a.** When the city of Sorel has reached the limit of its borrowing power, as fixed by article 595, every subsequent loan shall be subject to the formalities prescribed by article 5783 of the Revised Statutes, 1909, as replaced by the act 8 George V, chapter 60, section 11.”

An Act to amend the charter of the city of Levis

[Assented to, 4th of March, 1919]

WHEREAS the city of Levis has, by its petition, re-

 presented that it is in the interest of the proper management of its affairs that it be granted additional powers, and that its charter, the act 6 Edward VII, chapter 49, as amended by the acts 9 Edward VII, chapter 87, and 6 George V, chapter 49, be again amended; and it is expedient to grant its prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Section 10 of the act 6 Edward VII, chapter 49, is 6 Ed. VII, c. 49, s. 10, replaced.
 replaced by the following:

“**10.** The city of Levis, in the county of Levis, is bounded Boundaries of the city.
 in front to the northwest by the river St. Lawrence at a depth of forty feet at low water; in rear, to the southeast, by the parishes of St. Téléphore, St. David de l'Auberivière, and by a portion of the village of Bienville; on one side, towards the northeast, by the said village of Bienville, and on the other side to the southwest by the Etchemin river and by the parishes of St. Romuald and St. Téléphore; measuring about one hundred and thirty-two arpents in front, and containing in superficies about two thousand two hundred and twenty-two acres.”

“**11.** The territory of the city of Levis is divided into Division into wards.
 four wards, namely: St. Lawrence Ward, Lauzon Ward, Notre Dame Ward, and Villemay Ward.

The numbers mentioned in the present description are Description of wards.
 the numbers of the official cadastre for each of such wards.

St. Lawrence Ward is bounded as follows:

In front to the northwest by the river St. Lawrence at a St. Lawrence Ward.
