An Act to amend the charter of the city of Fraserville

[Assented to, 4th of March, 1919]

Preamble. **W**HEREAS the city of Fraserville has, by its petition, represented that it has become expedient and in the public interest to amend the charter of the city by changing the name of the said city and substituting therefor the name of "Rivière-du-Loup";

And whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1 Geo. V, c. 56, s. 1, replaced. **1.** Section 1 of the act 1 George V (1st session), chapter 56, is replaced by the following:

Name. **"1.** This act shall be cited as: "the charter of the city of Rivière-du-Loup".

The provisions of the said act shall not prejudicially affect acquired rights."

Id., s. 2, replaced. **2.** Section 2 of the act 1 George V (1st session), chapter 56, is replaced by the following:

Name of city. **"2.** The inhabitants and rate-payers of the former town of Fraserville, and of the former city of Fraserville, and their successors, shall be and remain a corporation and body politic under the name of "The City of Rivière-du-Loup".

Id., s. 3, replaced. **3.** Section 3 of the act 1 George V (1st session), chapter 56, is replaced by the following:

City separate from county. **"3.** The city of Rivière-du-Loup is and shall remain separate from the county of Temiscouata for municipal purposes."

Id., s. 4, replaced. **4.** Section 4 of the act 1 George V (1st session), chapter 56, is replaced by the following:

"4. The city of Rivière-du-Loup shall hereafter be subject to the provisions of the Cities and Towns' Act, (articles 5256 to 5884 of the Revised Statutes, 1909, as amended) except in so far as they may be inconsistent with the provisions of this act.

The charter of the town of Fraserville, 3 Edward VII, chapter 69, and the acts amending the same, are repealed."

7. Section 10 of the act 1 George V (1st session), chap-Id., s. 10,

“10. The city of Rivière-du-Loup, situated in theBoundaries
county of Témiscouata, in the district of Kamouraska, in of city.
the Province of Quebec, shall be bounded as follows:

On the northwest by the river St. Lawrence; on the southwest by the division line between Nelson Caron's land and lots Nos. 218, 220, 221 and 222 of the official cadastre of the city of Rivière-du-Loup, starting from the river St. Lawrence and following a southeasterly direction to the front line between the first and second ranges of the parish of St. Patrice de la Rivière-du-Loup; on the southeast by the front line between the first and second ranges of the said parish, starting from Nelson Caron's land following a northeasterly direction to the division line of lots Nos. 209-8, 618 and 619 of the cadastre of the city of Rivière-du-Loup and Placide Therriault's land; thence following such division line between lots Nos. 209-8, 618 and 619 and Placide Therriault's land, running in a southeasterly direction one hundred feet, English measure, south of the lot occupied by the Intercolonial Railway; thence following a northeasterly direction to the northeastern boundary of the seigniorial domain of the estate of Wm. Fraser, five thousand three hundred and seventy six feet, English measure, south of the front line between the first and second ranges of the said domain; in the northeast by the northeastern boundary of the seigniorial domain starting from the line situated five thousand three hundred and seventy six feet to the south of the front line between the first and second

ranges, following a northwesterly direction to the land of Mr. Jules Viel, being No. 19 of the cadastre of the city of Rivière-du-Loup; thence by the division line between the land of the said Mr. Jules Viel and the lots of the second range of the village of St. Antoine in the parish of St. Patrice de la Rivière du Loup following a northeasterly direction to Arthur Pelletier's farm; thence by the line bounding the east side of lots Nos. 19, 14, 10, 8-1, 8 and 7 of the cadastre of the city of Rivière-du-Loup, following a northwesterly direction to the front line of the first range called l'Anse au Persil range, in the parish of St. Patrice de la Rivière-du-Loup; thence by the said front line following a southwesterly direction to Philadelphie Picard's land; thence by the division line of lots Nos. 5, 4, 3, 1-B of the cadastre of the city of Rivière-du-Loup and the lands of Fabien Plourde, following a northwesterly direction to the river St. Lawrence.

Government wharf within city. The Federal Government wharf shall be included in the limits of the city."

Id., s. 11, replaced. **8.** Section 11 of the act 1 George V (1st session), chapter 56, is replaced by the following:

Wards. **"11.** The city of Rivière-du-Loup is divided into three wards, called: North ward, Centre ward and South ward, as defined by the by-laws in force."

Coming into force. **9.** This act shall come into force on the day of its sanction.

CHAP. 101

An Act to amend the charter of the town of Chicoutimi

[Assented to, 17th of March, 1919]

Preamble. **W**HEREAS the town of Chicoutimi has by its petition represented that it is necessary for the proper administration of the affairs of the town that amendments be made to its charter, the act 4 Edward VII, chapter 62, as amended by the act 8 Edward VII, chapter 91;

Whereas, in order to encourage manufacturing within the limits of the said town, the council of the said town has entered into agreement with Price Brothers & Company, Limited, a body politic and corporate having its principal place of business in the city of Quebec, on the 23rd of December, 1918, by an authentic deed bearing the No. 14196 of the minutes of George St. Pierre, N.P., which con-
