

## C H A P. 112

An Act to annex to the parish of St. Jean des Piles, county of Champlain, certain lots of the parish of Ste. Flore, county of St. Maurice, for civil, municipal and school purposes

[Assented to, 4th of March, 1919]

**W**HEREAS Messrs. Ulderie Beaulac, merchant ; Preamble.  
Euchariste Desaulniers, farmer; Elie Desaulniers, farmer; Louis Gelinas, annuitant; Cyprien Lesieur, farmer; and Napoleon Lajoie, farmer, have, by their petition, set forth the following among other reasons:—

That lots Nos. 402 to 407 inclusive of range C; lots Nos. 408 to 431 inclusive of the St. Alexandre range; lots Nos. 476 to 492 inclusive of the St. Théophile range; lots Nos. 493 to 498 inclusive of range B, belong to the parish of Ste. Flore, county of St. Maurice;

That the majority of the owners of the said lots in the parish of Ste. Flore, county of St. Maurice, reside in the parish of St. Jean des Piles, county of Champlain, near the said lots;

That during the summer season the owners of the said lots have no access to nor exit from the same otherwise than by the parish of Ste Flore;

That the majority of the said owners, all of St. Jean des Piles, are settling on the said lots;

That the said lots in the parish of Ste. Flore are contiguous to the said parish of St. Jean des Piles, and, by annexing them to the latter it would contribute to enlarge it without harm to the said parish of Ste. Flore, which is already a very large one;

That it is urgent, for the above reasons, to annex the said lots in the parish of Ste. Flore, county of St. Maurice, to the parish of St. Jean des Piles, county of Champlain, for civil, municipal and school purposes;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:—

**1.** Lots Nos. 402 to 407 inclusive of range C; lots Nos. 408 to 431 inclusive of the St. Alexandre range; lots Nos. 476 to 492 inclusive of the St. Théophile range; lots 493 to 498 inclusive of the St. Jean des Piles range; <sup>Annexation of lots.</sup>

498, inclusive, of range B, as the said numbers appear on the official plan and book of reference of the cadastre of the parish of Ste. Flore, are detached from the said parish of Ste. Flore, county of St. Maurice, and annexed to the parish of St. Jean des Piles, county of Champlain.

**2.** All the above described territory of the said parish of Ste. Flore, county of St. Maurice, shall, from the sanction of this act, form part of the parish of St. Jean des Piles, county of Champlain, for civil, municipal and school purposes.

**3.** The said territory so annexed shall form part of the county of Champlain for all purposes; the numbers 11 and 67 of article 67; the numbers 12 and 70 of article 74, and numbers 11 and 64 of article 75 of the Revised Statutes, 1909, are amended accordingly.

## CHAP. 113

An Act to detach certain lots from the city of Lévis (St. Laurent ward), and annex them to the municipality of St. David de l'Auberivière, Lévis county

[Assented to, 4th of March, 1919]

Preamble.

**W**HEREAS Messrs Jos. T. Dussault, physician; Antenor Martineau, notary; Jos Eugène Carrier, butcher; Albéric Martineau, farmer; Arthur Rouleau, carpenter; Gaudias A. Bonneau, railway employee; Louis Philippe Gagnon, joiner and contractor; Ernest Bonneau, joiner; André Lamontagne, annuitant, all of St. David de l'Auberivière, Levis county, have by their petition represented that it is in the interest of the ratepayers and of the proper administration of the affairs of the municipality of St. David, Levis county, that certain lots formerly included in its territory should now be detached from the city of Lévis and annexed to the municipality of St. David de l'Auberivière, Lévis county;

Whereas it is represented that this is necessary in the interest of the ratepayers owning the said lots, since they form an isolated group, owing to the progress of the municipality of St. David, and moreover the city of Lévis
