

## C H A P. 134

An Act to incorporate the School for Crippled Children,  
Montreal

[Assented to, 4th of March, 1919]

**W**HEREAS Lieutenant-Colonel Alexander Mackenzie  
Forbes, M.D., of Westmount, Reverend Doctor Her- Preamble.

bert Symonds, of Montreal, Reverend Doctor Elson I. Rexford, of Montreal, Doctor R. Stanley Weir, King's Counsel, of Westmount, Mr. W. D. Lighthall, King's Counsel, of Westmount, E. W. T. Raddon, Esquire, Treasurer, of Westmount, Miss Sarah Agnes Tyndale, Principal, of Montreal, Miss Georgina Hunter, formerly Principal of Montreal High School, of Montreal, Miss Lucinda Esther Lawless, teacher, of Montreal, Miss Lily Catherine Lamb, teacher, of Montreal, and Miss Alice Murray, teacher, of Montreal, have by their petition represented that they wish to establish and incorporate themselves and their successors a body politic and corporate for the purposes of caring for, training and educating crippled and infirm children, and desire to have power and authority for such purpose; and

Whereas such incorporation would be of public benefaction and utility, and it is expedient to grant their prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The persons above mentioned, together with all others Corporation constituted.  
who may join them and become members of the association constituted.  
as hereinafter provided, are hereby incorporated under the constituted.  
name of "The School for Crippled Children, Montreal", for Objects and  
the purpose of caring for, training and educating crippled powers of  
and infirm children and ministering to the relief of their corporation.  
physical, mental and moral necessities so as to make them,  
as far as practicable, useful members of society and not  
entirely dependent upon the benefactions of others; with  
power to receive, hold and enjoy moveable and immoveable  
property of all kinds whatsoever, whether by gift, purchase,  
devise, will, lease or otherwise, and any such immoveable  
property or properties to hypothecate as security for pur-  
poses compatible with the objects of the corporation, and  
the said properties moveable or immoveable to let, lease,  
exchange, sell or otherwise alienate or dispose of, without  
prejudice to such trust and conditions as may be declared  
concerning the same in the title under which they may be  
held; provided always that any such immoveable property

shall not exceed in annual value the sum of fifty thousand dollars.

**Head office.**     **2.** The head office and corporate seat of the school shall be in the city of Montreal.

**Powers of corporation.**     **3.** The corporation shall have all the powers conferred on corporations by law in addition to the special powers herein granted.

**Members of corporation.**     **4.** The members of the corporation shall consist of the persons named in the preamble of this act and all such persons as they shall elect as members, whether as additions to their number or to fill any vacancies therein that may occur through death, resignation or other causes as shall be provided for in the by-laws of the said corporation.

**Board of governors.**     **5.** The affairs of the corporation shall be vested in and managed by a board of governors which shall be elected by the members of the corporation annually, and such board of governors shall have power to make rules and by-laws for the nomination and election of officers and members, and for the administration, audit and management of the affairs of the corporation, provided that the same be not contrary to law or the provisions of this act.

**Annual statement for Lieut.-Governor in Council.**     **6.** The corporation shall every year transmit to the Lieutenant-Governor in Council a detailed statement of its property, a copy of its rules and regulations and a certified list of its officers and agents.

**No liability of members for debts of corporation.**     **7.** No member of the corporation shall be individually liable for any debts incurred by the corporation, or for any acts or operations which the said corporation is hereby authorized to undertake or perform.

**Coming into force.**     **8.** This act shall come into force on the day of its sanction.
