

C H A P. 135

An Act to incorporate the *Sœurs Franciscaines Missionnaires de l'Immaculée-Conception*

[Assented to, 4th of March, 1919]

WHEREAS it has been represented by the petition of Preamble.

Dame Julie Michaud, in religion Sister Marie-Marguerite; Dame Catherine McDonough, in religion Sister Marie-Magdalen, and Dame Marie-Séraphini, in religion Sister Marie-Luc, that there exists in this Province a religious community whose members devote themselves to the education of children and to the assistance of the poor and sick, and that such persons have prayed to be incorporated under the name of *Les Sœurs Franciscaines Missionnaires de l'Immaculée-Conception*, and whereas it is expedient to grant this prayer, which has received the assent of the bishop of the diocese of Montreal;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Dame Julie Michaud, in religion, Sister Marie-Marguerite; Dame Catherine McDonough, in religion, Corporation constituted. Sister-Marie Magdalen, and Dame Marie-Séraphini, in religion, Sister Marie-Luc, domiciled in Montreal, and such other persons as now or will in future form part of the community of the *Sœurs Franciscaines Missionnaires de l'Immaculée Conception*, in accordance with its constitution and by-laws, are incorporated under the name of: *Sœurs Franciscaines Missionnaires de l'Immaculée Conception*.

2. Under such name the corporation shall have perpetual Powers of succession and enjoy all the privileges granted by law to corporation. incorporated religious societies; and may appear before the courts, acquire, possess, sell and alienate moveable and immoveable property under any legal title, and hypothecate these immoveables, provided that it shall not acquire immoveables for an amount exceeding three hundred thousand dollars, subject to the provisions of article 6113 of the Revised Statutes 1909.

3. The corporation may found convents, houses and Convents, etc. branches for its work.

4. The corporation shall be governed in accordance with Regulations the rule, constitution and regulations of *l'Ordre des Sœurs* of corporation.

Franciscaines Missionnaires de l'Immaculée-Conception, and it may adopt regulations for the administration of its property, its internal management, the election, number and powers of its officers, directors and councillors, the admission and withdrawal of its members, and generally all regulations for the good of the corporation and not contrary to law.

5. The principal seat of the corporation shall be in the city of Montreal. Nevertheless it may be established in another place, upon the corporation giving notice thereof in the *Quebec Official Gazette*, and producing a written declaration at the office of the Provincial Secretary and at the office of the Prothonotary of the Superior Court of the district in which the principal seat of the corporation is to be established.

6. The corporation shall every year transmit to the Provincial Secretary a detailed statement of its moveable and immoveable property.

7. This act shall come into force on the day of its sanction.

CHAP. 136

An Act to incorporate "*Le Tiers-Ordre de Saint-Dominique*"

[Assented to, 4th of March, 1919]

Preamble.

WHEREAS there exists in Montreal a canonical fraternity of the Third Order of Saint Dominic, whose object is the personal sanctification of the members composing it and charitable and religious works, and the persons hereinafter named have, by their petition, represented that the better to attain the abovementioned objects, it necessary to pass an act incorporating them under the name of "*Le Tiers-Ordre de Saint-Dominique*"; and

Whereas it is expedient to grant their prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:
