**5.** The principal seat of the corporation shall be in the city of Montreal. Nevertheless it may be established in another place, upon the corporation giving notice thereof in the *Quebec Official Gazette*, and producing a written declaration at the office of the Provincial Secretary and at the office of the Prothonotary of the Superior Court of the district in which the principal seat of the corporation is to be established.

**6.** The corporation shall every year transmit to the Provincial Secretary a detailed statement of its moveable and immoveable property.

## CHAP. 136

An Act to incorporate "*Le Tiers-Ordre de Saint-Dominique*"

[Assented to, 4th of March, 1919]

Preamble.

**W**HEREAS there exists in Montreal a canonical fraternity of the Third Order of Saint Dominic, whose object is the personal sanctification of the members composing it and charitable and religious works, and the persons hereinafter named have, by their petition, represented that the better to attain the abovementioned objects, it necessary to pass an act incorporating them under the name of "*Le Tiers-Ordre de Saint-Dominique*"; and

Whereas it is expedient to grant their prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Corporation  
constituted.

**1.** The Very Reverend Father Alphonse Emile Langlais, of Saint Hyacinthe, Provincial of the Order of Dominicans or Preaching Friars in Canada, the Very Reverend Father Raymond Marie Rouleau, of Ottawa, the Very Reverend

Father Pie Marie Béliveau, of Quebec, the Reverend Father Marie Dominique Laferrière, of Montreal, and other persons who now are or will hereafter become members of the provincial council of this religious order, under its present or future rules and constitutions, are incorporated under the name of "*Le Tiers-Ordre de Saint-Dominique*".

**2.** The persons above named and those who, under the statutes and by-laws, will succeed them in office, shall be the directors or dignitaries of the corporation. Directors.

**3.** The corporation may establish in any part of the Province of Quebec, distinct fraternities of men or women, under the names and titles set forth in the letters granted by it to constitute these fraternities, and the members of each fraternity shall be a corporation, subject to the rules and constitutions of the corporation and to those of the Order of Dominicans or Preaching Friars. Power to establish other fraternities.

**4.** Each fraternity shall be incorporated under the following name: "*Tiers-Ordre de Saint-Dominique, Fraternité de* (canonical name of the fraternity)". Name of fraternity.

After being established and before acting as a corporation, the fraternity shall cause to be registered at length in the registration office of the city, county or of the registration division where it will be established, a declaration signed by its officers or dignitaries, setting forth the fact of its establishment, the date of the letters establishing it, its corporate name and the name of its officers or dignitaries. Declaration to be registered.

**5.** The corporate seat of the corporation shall be in the city of Saint Hyacinthe or in any other place of the Province appointed by the Provincial of the Order of Dominicans or Preaching Friars of Canada. The latter shall give notice of any change to the Provincial Secretary and have the same published in the *Quebec Official Gazette*. That of the fraternities shall be in the place where each one is established. Corporate seat.

**6.** The corporation and fraternities shall be governed by the rule of the Third Order, its regulations and usages approved or established by the lawful authorities of the Order of Dominicans or Preaching Friars; they may, moreover, within the limits of their respective attributes, adopt by-laws respecting the election, committees, internal management, the number of members required for a quorum at meetings, the qualification and admission of members, their dismissal or withdrawal, the administration, management Powers to adopt by-laws, etc.

and control of property belonging to them and of their respective business, provided they be not contrary to the present charter nor to the laws of this Province, and be approved by the Provincial of the Dominicans or Preaching Friars in Canada.

**7.** The affairs of the corporation and those of the various fraternities shall be managed by dignitaries of either sex, as the case may be, duly appointed for this purpose. The number, qualification, appointment or election of these dignitaries, the length of their term of office and of their powers and duties shall be determined by the rule of the Third Order or the lawful authorities of the Order of Dominicans or Preaching Friars. In the fraternities, the director or president of the council of management shall be a Dominican Father appointed by the Provincial of the Order of Dominicans or Preaching Friars in Canada.

Power to  
acquire  
property.

**8.** The corporation and fraternities may, each separately and under its own name, acquire property of any kind, moveable or immoveable, provided that its annual value does not exceed five thousand dollars for each one of them; they may respectively acquire, lease, alienate, borrow, hypothecate, act and contract in any manner whatsoever, provided they do nothing incompatible with the rule of the Third Order and the laws of this Province; but no fraternity shall become indebted for more than five hundred dollars without the assent of the corporation.

No fraternity shall enter into a contract binding the corporation without the assent of the council of this latter.

Extinction

**9.** Any fraternity may be declared extinct by the corporation, if it has remained a year without a regularly appointed council, or for any other reason laid down by the rule of the Third Order, its regulations and usages approved or established by the lawful authorities of the said Order of Dominicans or Preaching Friars.

**10.** When a fraternity is dissolved or declared extinct, in conformity with the statutes or by-laws of the corporation or constitution of the Order of Dominicans or Preaching Friars, its property shall belong to the corporation. In this case, the corporation shall be bound to pay the debts contracted, and to fulfil the engagements entered into by said fraternity.

**11.** The corporation shall every year transmit to the Provincial Secretary a detailed statement of its moveable

and immoveable property, as well as a copy of its by-laws and the names of its officers.

## CHAP. 137

An Act to incorporate *l'Oeuvre des Vocations Tardives*

[Assented to, 17th of March, 1919]

**W**HEREAS Abbé Joseph A. E. Bernier and Abbé Denis <sup>Preamble.</sup>  
Garon, both of St. Victor, in the county of Beauce;  
Canon C. Joseph Hallé, of the city of Quebec; Abbé J.  
Alfred Morisset, of St. Joseph, in the county of Beauce,  
and Canon C. Charles Gagné, of the city of Quebec, have  
by their petition represented:

That *l'Oeuvre des Vocations Tardives* was founded and  
exists at St. Victor, in the county of Beauce, to assist young  
men who are destined to the ecclesiastical state in the  
Roman Catholic Church, especially those whose vocation  
may have manifested itself late, to help and give them the  
fulfilment of their wishes and give them the means of  
pursuing the necessary studies; .

That this institution has received the approval of the  
Roman Catholic religious authority of the diocese of  
Quebec;

That it has become expedient to entrust this work to a  
corporation regularly constituted, formed for this purpose;  
and

That the above named persons represent the interests  
involved in this work and wish to be incorporated for this  
purpose, under the name of *l'Oeuvre des Vocations Tardives*.

Whereas it is expedient to grant their prayer;

Therefore His Majesty, with the advice and consent of

Quebec, enacts as follows:
