

exceeding three months, or both, in the discretion of the court before which the conviction is had.

“6265b. Every person who listens to or acquires ^{Same} knowledge of any conversation or message passing over ^{penalty for} the lines of an electric telephone system, not addressed to ^{other} or intended for such person, and divulges the same or the ^{persons.} purport or substance thereof, except when lawfully authorized or directed so to do, shall be liable to the same penalty and imprisonment as are enacted in article 6265a.”

2. This act shall come into force on the day of its ^{Coming into} sanction. ^{force.}

CHAP. 64

An Act to amend the Revised Statutes, 1909, respecting companies to facilitate the transmission of timber down rivers and streams

[Assented to 9th February, 1918]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Article 6269 of the Revised Statutes, 1909, is amended ^{R. S., 6269,} by replacing the words: “Minister of Public Works and ^{am.} Labour”, in the third and fourth lines of the third paragraph thereof, by the words: “Minister of Lands and Forests”.

2. Article 6272 of the said statutes is amended: ^{R. S., 6272,}
a. By replacing the words: “Minister of Public Works ^{am.} and Labour”, in the third line thereof, by the words: “Minister of Lands and Forests”;

b. By replacing the words: “Minister of Public Works and Labour”, in the tenth and eleventh lines thereof, by the words: “Minister of Lands and Forests”.

3. Article 6274 of the said statutes is amended: ^{R. S., 6274,}
a. By replacing the words: “Minister of Public Works ^{am.} and Labour”, in the second line thereof, by the words: “Minister of Lands and Forests”;

b. By replacing the words: “Minister of Public Works and Labour”, in the sixth and seventh lines thereof, by the words: “Minister of Lands and Forests”.

R. S., 6278, am. **4.** Article 6278 of the said statutes is amended by replacing the words: "Minister of Public Works and Labour", in the fourth line thereof, by the words: "Minister of Lands and Forests".

R. S., 6291, am. **5.** Article 6291 of the said statutes is amended by replacing the words: "Minister of Public Works and Labour", in the third line of the first paragraph thereof, by the words: "Minister of Lands and Forests".

R. S. 6292, am. **6.** Article 6292 of the said statutes is amended by replacing the words: "Minister of Public Works and Labour", in the sixth line of the first paragraph thereof, by the words: "Minister of Lands and Forests".

R. S. 6316, am. **7.** Article 6316 of the said statutes is amended by replacing the words: "Minister of Public Works and Labour", in the sixth line thereof, by the words: "Minister of Lands and Forests".

R. S. 6322, am. **8.** Article 6322 of the said statutes is amended:
a. By replacing the words: "Minister of Public Works and Labour", in the sixth and seventh lines of the first paragraph thereof, by the words: "Minister of Lands and Forests";
b. By replacing the words: "Minister of Public Works and Labour", in the first line of the second paragraph thereof, by the words: "Minister of Lands and Forests".

R. S. 6338, am. **9.** Article 6338 of the said statutes is amended by replacing the words: "Minister of Public Works and Labour", in the seventh line thereof, by the words: Minister of Lands and Forests".

Coming into force. **10.** This act shall come into force on the day of its sanction.
