

## C H A P . 65

An Act to amend article 6763 of the Revised Statutes,  
1909, respecting co-operative syndicates

[Assented to 9th February, 1918]

**HIS MAJESTY**, with the advice and consent of the  
Legislative Council and of the Legislative Assembly  
of Quebec, enacts as follows:

**1.** Article 6763 of the Revised Statutes, 1909, as R. S., 6763,  
amended by the acts 2 George V, chapter 43, section 1, <sup>am.</sup>  
and 5 George V, chapter 68, section 1, is again amended by  
adding thereto the following paragraph:

“Notwithstanding the foregoing, the territorial limit <sup>Extension of</sup>  
within which the association may operate, may be extend- <sup>territory.</sup>  
ed with the approval of the Lieutenant-Governor in  
Council.”

## C H A P . 66

An Act to amend the Quebec Insurance act with regard to  
insurance agents

[Assented to 9th February, 1918]

**HIS MAJESTY**, with the advice and consent of the  
Legislative Council and of the Legislative Assembly  
of Quebec, enacts as follows:

**1.** Article 6960*k* of the Revised Statutes, 1909, as R. S., 6960*k*,  
enacted by the act 7 George V, chapter 46, section 1, replaced.  
is replaced by the following:

“**6960*k***. The fee payable in respect of each agent’s <sup>Tariff of</sup>  
license or renewal thereof shall be as follows: <sup>fees for</sup>

By agents transacting all classes of insurance or fire <sup>agent’s</sup>  
insurance only: <sup>licenses.</sup>

In cities.....	\$	10.00
Elsewhere .....	\$	5.00

By agents transacting life insurance only:

In cities .....	\$	5.00
Elsewhere .....	\$	3.00

By agents transacting industrial insurance only or funeral insurance only .....\$ 2.00'

Coming into force. **2.** This act shall come into force on the first day of January, 1919.

## C H A P . 6 7

An Act to amend article 7033 of the Revised Statutes, 1909, respecting fire insurance companies

[Assented to 9th February, 1918]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

R. S., 7033, am. **1.** Article 7033 of the Revised Statutes, 1909, is amended by striking out the words: "and the insurance of mercantile and manufacturing risks shall, if on the cash system, be for terms not exceeding one year", in the fourth, fifth and sixth lines of paragraph 1 thereof.

Coming into force. **2.** This act shall come into force on the day of its sanction.

## C H A P . 6 8

An Act to amend the Revised Statutes, 1909, respecting work done on water-courses by riparian proprietors

[Assented to 9th February, 1918]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

R. S., 7295a, enacted. **1.** The following article is inserted in the Revised Statutes, 1909, after article 7295 thereof, to wit:

Approval of Lt.-Gov. in C. required in certain case. **"7295a.** 1. No flood-gate, flume, embankment, dam, dike or similar work, the construction or maintenance of which will cause public property or the property of third persons or public or private rights to be affected, either by the backing up of the water or otherwise, shall be constructed or maintained in any of the water-courses referred to in article 7295, unless the site on which it is to be con-
