

## C H A P . 97

## An Act to incorporate the town of Cap de la Madeleine

[Assented to 9th February, 1918]

Preamble.

**W**HEREAS the municipal corporation of Ste. Marie du Cap de la Madeleine, has, by its petition, prayed that, for the better municipal administration of the locality, an act be passed to erect the said municipality of the parish of Ste. Marie du Cap de la Madeleine, as a town municipality governed by the Cities and Towns' Act; and it is expedient to grant the prayer to that effect contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Short title.

**1.** This act shall be cited as the "Charter of the town of Cap de la Madeleine".

Town corporation created.

**2.** The inhabitants and ratepayers of the said municipality are constituted a town corporation under the name of "Town of Cap de la Madeleine", for municipal purposes.

Territory of town.

**3.** The town of Cap de la Madeleine comprises the territory included in the following limits: starting from the point determined by the intersection of the line dividing lots Nos. 106 and 107 of the cadastre of the parish of Cap de la Madeleine with the north shore of the St. Lawrence river, and towards the northwest following the said line dividing lots Nos. 106 and 107 to its intersection with the northwestern side of the public road; thence towards the southwest, following the northwestern side of the public road to its intersection with the line dividing lots Nos. 111 and 112 of the cadastre of the parish of Cap de la Madeleine; thence, towards the northwest, following the line dividing lots Nos. 111 and 112 to its intersection with the base line dividing the lots of the concession of the river, and the lots of the St. Malo range; thence, towards the southwest, following the above-mentioned base line to its intersection with the line dividing lots Nos. 427 and 428 of the cadastre of the parish of Cap de la Madeleine; thence towards the northwest following the line dividing lots Nos. 427 and 428, to its intersection with the line dividing the lots of the Grandes Prairies, on the south-east side, and the lots of the St. Malo range; thence towards the southwest, following the last-mentioned base

line, to its intersection with the line dividing lots Nos. 536 and 538; thence, towards the northwest, following the line dividing lots Nos. 536 and 538, 537 and 540, and its prolongation across lot No. 539 to its intersection with the base line dividing the lots of the Grande Prairies range on the southeast side and northwest side; thence, towards the northeast, following the last-mentioned base line to its intersection with the line dividing lots Nos. 567 and 568; thence, towards the northwest, following the line dividing lots Nos. 567 and 568 to its intersection with the boundary line of the parish; thence, towards the northwest and southwest, following the boundary line of the parish to its intersection with the stream at the Chapel; thence, towards the south, following the bed of the said stream as far as its mouth at the St. Maurice river; thence, towards the east and southeast, following the north shore of the St. Maurice river as far as its mouth in the St. Lawrence river; thence, towards the east and the northeast, following the north shore to the St. Lawrence river to the point determined by the intersection of the line dividing lots Nos. 106 and 107 from the north shore.

4. The town shall not form part of the county of Champlain for municipal purposes. Town detached from county.

5. The town of Cap de la Madeleine, hereby incorporated, succeeds to the rights, obligations, claims, privileges and actions of the corporation of the parish of Ste. Marie du Cap de la Madeleine, and replaces it for all lawful purposes. Succession to rights, &c., of parish.

6. All by-laws, resolutions, *procès-verbaux*, assessment rolls, dues, lists, plans and other municipal acts or documents whatsoever, made and consented to by the council of the corporation of the parish of Ste. Marie du Cap de la Madeleine, shall continue to have their effect until amended, cancelled, repealed or executed. By-laws, &c., to continue in force.

7. The town of Cap de la Madeleine shall be subject to the provisions of the Cities and Towns' Act, except when inconsistent with the provisions of this act. Provisions applicable.

8. The municipal council of the town shall consist of a mayor and six aldermen elected by all the rate-payers for the whole town without any division into wards. Four members of the council shall constitute a quorum. Composition of council.

9. The nomination of candidates for the first general Nomination

- of candidates. election shall take place on the fourth Tuesday after the coming into force of this act, if it be a juridical day, and, if not, on the next following juridical day. The voting, if any be necessary, shall take place on the tenth following day, if it be a juridical day, and, if not, on the next following juridical day. The returning-officer for such election shall be a person designated by the council. The second election shall be held on the first juridical day of July, 1919, and the subsequent general elections shall be held on the first juridical day of July, 1921, and, afterwards, every second year on the first juridical day of July.
- First election.
- Subsequent elections.
- One polling place. **10.** The polling shall be held at one place only, indicated by resolution of the council or, in its default, by the returning-officer.
- No division into wards. **11.** The town shall form but one ward represented in the council by all the aldermen.
- Notice by returning-officer. **12.** Eight days at least before the nomination for the first election, the returning-officer shall give public notice under his signature, setting forth:
- a. The place, day and hour for the nomination of candidates;
  - b. The place where and the day on which the poll for taking the votes of the electors will be held, if a poll is necessary;
  - c. The appointment of the election clerk.
- Valuation roll, &c., to continue to apply. **13.** The valuation roll and the electors' list, hitherto governing the municipality of Ste. Marie du Cap de la Madeleine, shall continue to apply to the present municipality until amended, repealed or replaced by the council of the present municipality.
- Term of present council. **14.** The present mayor and councillors of the parish of Ste. Marie du Cap de la Madeleine shall remain in office until the election of their successors.
- First sitting of new council. **15.** The first sitting of the council after the first election shall be held in the hall of the council of the parish of Ste. Marie du Cap de la Madeleine.
- Costs, &c. **16.** The costs, fees and expenses for the purposes of this incorporation, shall be paid by the town.

**17.** The town may, by by-law of its council:

Powers of  
council.

*a.* Acquire the water-works and sewerage systems constructed in its territory and belonging to the water-works company of Cap de la Madeleine;

*b.* Pay the price thereof by undertaking the payment of the debentures affecting such systems, by issuing and delivering its own debentures to the vendors, by loans or otherwise, or partly in one such way and partly in the other.

**18.** This act shall come into force on the day of its sanction. Coming into

## C H A P . 9 8

An Act to incorporate the village of Ste. Rose as a town

[Assented to 9th February, 1918]

**W**HEREAS the corporation of the village of Ste. Rose Preamble.

has, by its petition, represented that the provisions of the Quebec Municipal Code no longer suffice for its present needs, and it has become necessary to take more extensive measures for the administration of the said village; and it has prayed to be incorporated as a town under the The Cities and Towns' Act, under the name of the "Town of Ste. Rose";

Whereas it is in the interest of the ratepayers of the said village of Ste. Rose that the said petition be granted;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** This act shall be cited as "The charter of the Town Short title.

**2.** The town of Ste. Rose is subject to the provisions Provisions

of chapter first of title eleventh of the Revised Statutes, 1909, and its amendments (articles 5256 to 5884), except in so far as they may be inconsistent with the provisions of this act.

**3.** The town of Ste. Rose, hereby incorporated, shall Succession
