

## C H A P . 103

An Act to fix the limits and boundaries of the municipality  
of St. Octave de Dosquet, for civil and school  
purposes

[Assented to 9th February, 1918]

**W**HEREAS Messrs. J. E. Poitras, merchant; Albert Desharnais, farmer; Zenophon Bergeron, farmer, and Philibert Martineau, farmer, all of St. Octave de Dosquet, in the county of Lotbinière, have, by their petition, represented: Preamble.

That by a proclamation of the Lieutenant-Governor of the Province, dated the 24th December, 1912, the limits and boundaries of the canonical parish of St. Octave de Dosquet, in the counties of Lotbinière and Megantic, were described and determined as follows:

"The parish of St. Octave de Dosquet in the counties of Lotbinière and Megantic, is made up of portions of each of the parishes of Ste. Anastasie de Nelson, of St. Flavien and of St. Agapit, and its territory comprises:

"a. In the parish of Ste. Anastasie de Nelson, lots Nos. 1, 2, 3, 4, 5, 6 of each of ranges I, II, III and lots Nos. 1, 2, 3a, 3b, 4, 5 and 6 of range IV of the official cadastre of Nelson township;

"b. In the parish of St. Flavien, the lots of the official cadastre of that parish, from and including lots Nos. 439a and 440, to and including No. 473, of St. Joseph range, southwest of the central road; those from and including lots Nos. 318a, 319a, 319b, 320 to and including No. 367, of St. Joseph range, northeast of the central road; also the lots of the official cadastre of the parish of St. Agapit Nos. 61 to 78, which were annexed to the said parish of St. Flavien in 1904;

"c. In the parish of St. Agapit, the lots of the official cadastre of that parish Nos. 51 to 60 inclusive in the second concession of South Davidson, and those from 79 to 88 inclusive in the first concession of North Davidson.";

That, by the said proclamation, the limits and boundaries above described, were confirmed, established and recognized;

That, by the said proclamation, it was declared and ordered that the parish of St. Octave de Dosquet, described as aforesaid, should be a parish for all civil purposes;

That the said parish of St. Octave de Dosquet is situated partly in the county of Lotbinière and partly in the county of Megantic;

That, in consequence of the said situation, it is necessary that an act be passed to erect as a parish municipality the territory now constituting the canonical and the civil parish of St. Octave de Dosquet;

That, since the proclamation, a municipal council of the said parish has been appointed, and has acted as such;

That it is necessary to ratify the by-laws, resolutions, *procès-verbaux*, orders, lists or municipal acts done or adopted by the said council;

That it is necessary, at the same time, to erect the whole territory of the said parish as a school municipality;

Whereas it is expedient to grant the prayer of the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The whole of the territory now constituting the canonical and the civil parish of St. Octave de Dosquet, as described in the preamble of this act, is erected as a parish municipality under the name of "The Municipality of the parish of St. Octave de Dosquet".

**2.** All by-laws, resolutions, *procès-verbaux*, orders, lists, rolls or municipal acts adopted or passed by the council of the parish of St. Octave de Dosquet since its existence, shall be considered to have been adopted or passed by a council having the necessary legal capacity.

School

**3.** The whole of the territory now constituting the canonical and the civil parish of St. Octave de Dosquet, as described in the preamble of this act, is erected as a school municipality under the name of the "School municipality of St. Octave de Dosquet".

**4.** All by-laws, resolutions, *procès-verbaux*, orders, lists, rolls or other acts adopted or passed by the school commissioners of the said parish of St. Octave de Dosquet, since its existence, shall be considered to have been adopted or passed by school commissioners having the necessary legal capacity.

**5.** This act shall in no wise affect the boundaries of the counties of Lotbinière and Megantic for the purposes of representation in the Legislative Assembly, but the municipality hereby created shall form part of the county of Lotbinière for all other purposes.

**6.** This act shall come into force on the day of its sanction.
