

C H A P . 128

An Act to incorporate *L'Œuvre du Petit Séminariste*

[Assented to 9th February, 1918]

Preamble. **W**HEREAS the director and councillors of *L'Œuvre du Petit Séminariste* have, by their petition represented:

That they have founded, at Chicoutimi, *L'Œuvre du Petit Séminariste* for the purpose of aiding in securing new members for the priesthood;

That Monseigneur Michel Thomas Labrecque, Bishop of Chicoutimi, has approved the foundation of this institution;

Whereas they pray to be incorporated, and it is expedient to grant their prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Corporation created. **1.** Abbés Elzéar DeLamarre, priest, director of the institution; Alma Larouche, rector of the Chicoutimi Cathedral; Louis Gagnon, parish priest of Chambord; M. P. Hudon, parish priest of La Malbaie; Guil. Tremblay, parish priest of Sacré Cœur, and J. E. Duchesne, director of the minor seminary of Chicoutimi, together with all persons who may be associated with or succeed them, are incorporated under the name of *L'Œuvre de Petit Séminariste*.

Perpetual succession. **2.** The corporation shall have perpetual succession and may have a common seal which it may alter at will.

Powers. **3.** The corporation may:

a. Appear before the courts in the same manner as any other person may do;

b. Accept, acquire and hold moveable and immoveable property under any legal title, provided the yearly revenue from the immoveables does not exceed fifteen thousand dollars;

c. Lease, sell, exchange, convey or otherwise dispose of all its moveable and immoveable property under any legal title, and also hypothecate its immoveable property;

d. Make by-laws respecting its internal government and the administration and disposal of its property, and amend or repeal the same when necessary;

e. Appoint officers, procurators and administrators and determine their number and powers;

f. In a word, exercise all the powers necessary for its objects.

4. The corporate seat of the corporation shall be in the town of Chicoutimi. Corporate seat.

5. The board of management shall consist of the director appointed by the bishop, of four councillors elected, and of the director of the minor seminary of Chicoutimi, who shall be a councillor *ex officio*. Board of management.

The petitioners shall continue to perform the duties of their office until replaced under the by-laws of the corporation.

6. All moneys, securities and other property now belonging to *L'Oeuvre du Petit Séminariste*, shall be transferred to the corporation. Moneys, &c.

7. The corporation shall transmit to the Lieutenant-Governor in Council whenever thereunto required by the Provincial Secretary a statement of its moveable and immoveable property, the names of its officers and a certified copy of its rules and by-laws. Statement to Lt.-Gov. in C.

8. This act shall come into force on the day of its sanction. Coming into force.

CHAP. 129

An Act respecting the building of the church, sacristy and
presbytery of the parish of *Notre-Dame du Perpétuel
Secours de Montréal*

[Assented to 9th February, 1918]

WHEREAS the *curé* and churchwardens of *l'œuvre et fabrique* of the parish of *Notre-Dame du Perpétuel Secours de Montréal* have, by their petition, represented:

That it is urgent for the well-being of the parish that a church and sacristy be built on the lot of land held by the *fabrique* for that purpose, and to enlarge and raise the presbytery now built on it;

That the provisions of chapter I of title IX of the Revised Statutes, 1909, do not meet the petitioners' needs; that, in particular, it is advisable, owing to the peculiar situation of the parish, to substitute a less complex organization to that of the corporation of parish trustees; that, more-
