10. To cover losses and the expenses arising from the carrying out of the said act of assessment, a sum of ten per cent of the said annual assessment may be added.

Interest on
instalments.

11. Interest at the rate of six per cent per annum shall be charged upon instalments not paid at maturity, and *l'œuvre et fabrique* of the said parish may recover the amount thereof in the ordinary manner.

Property
not to be
affected.

12. The assessment shall not affect the property of persons who are not Roman Catholics, except for payments matured and due when the said property belonged to Roman Catholics.

Assessment
to be levied
for how
long.

13. The right to levy the said assessment shall not last for a period of more than forty years or longer than may be necessary for extinguishing the debt of the said parish.

Costs, &c.
of this act.

14. The costs and fees incurred by the promoters of this act for obtaining its adoption, shall be paid by the *fabrique* of the parish of *St. Jean l'Evangéliste de Coaticook*.

15. This act shall come into force on the day of its sanction.

CHAP. 135

An Act to amend the charter of the Montreal General Hospital

[Assented to 9th February, 1918]

Preamble.

WHEREAS the Montreal General Hospital has, by its petition, represented:

That its charter of incorporation was revised and consolidated by the statute 1 George V (1st session), chapter 96; and

That it is expedient and necessary for the effective future operation and maintenance of the hospital that section 4 of its consolidated charter be amended; and

Whereas it is expedient to grant the said petition;

Therefore His Majesty, with the advice and consent

of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Section 4 of the act 1 George V (1st session), chapter 1 George V 96, is replaced by the following: (1910), c. 96, s. 4, replaced.

"4. The present life governors of the corporation and all other persons who shall hereafter be elected life governors shall be and are constituted a corporation under the name of "The Montreal General Hospital", and all persons who shall after the 1st of January, 1918, be elected life governors must qualify therefor by the payment of a fee of over one hundred dollars, subject to further contribution on their part of an annual sum exceeding fifteen dollars, the amount of such increased fee for qualification and the amount of such increased annual contribution, for life governors elected after the said date, to be decided by the board of management of the Montreal General Hospital, which board is granted the necessary powers for that purpose."

2. This act shall come into force on the day of its sanction. Coming into force.

CHAP. 136

An Act to amend the charter of the Corporation of English, German & Polish Jews of Montreal

[Assented to 9th February, 1918]

WHEREAS the Corporation of English, German and Polish Jews of Montreal, incorporated by the act 9-10 George IV, chapter 75, as amended by the acts 9 Victoria, chapter 96, and 2 Edward VII, chapter 95, has, by its petition, represented that it is advisable that the name of the Corporation be changed to Congregation *Shaar Hashomayim* (Gate of Heaven); that the increasing number of members of the corporation has rendered it necessary and advisable that the corporation should have increased power to hold property, and to own cemeteries, in Montreal, and elsewhere in the district of Montreal; that it is necessary that the corporation have power to borrow, alienate, hypothecate, sell, exchange and otherwise dispose of its immoveable property;

And whereas it is expedient to grant the prayer of the said petition;
