CHAP. 13

An Act to establish a new registration division at Mont-Laurier, in the county of Labelle, and to divide that county into two divisions for municipal and registration purposes

[Assented to 22nd December, 1916]

Preamble.

WHEREAS Jean-Baptiste Forget, merchant; Aldéric Ouellette, trader; both of the village of Mont-Laurier; Cyrille Lafontaine, farmer of Ferme-Neuve; Auguste L'Allier, farmer of the township of Robertson; Evariste Forget, farmer of the township of Campbell; Anthime Dubreuil, notary of the village of Mont Laurier, county of Labelle, have by their petition represented:

That in view of the great development and increase of population and business in the northern part of the county of Labelle known as the Colonization Region to the North West of Montreal; it has become urgent to establish a new division for municipal and registration purposes, with its chief place in the village of Mont-Laurier;

And whereas it is expedient to grant the prayer to that effect contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. On and after the 1st of January, 1918, the county of Labelle shall be divided into two registration divisions and two separate county municipalities.

Registry Office of division No. 2. **3.** The registry office of division No. 2 of the county of Labelle shall be kept in the court house at Mont-Laurier, in the rooms set apart for the purpose, from the

1st of January, 1918, and a registrar shall be appointed for that division according to law.

4. All laws in force respecting the registration of the various titles and deeds and all matters relating thereto, as well as those relating to registry offices and to the registrars and deputy-registrars appointed to the same, shall apply to the registration divisions established by this act, except in so far as they may be inconsistent with its provisions. 5. The chief place of the second division of the county of Labelle shall be at the village of Mont-Laurier. Chief place of 2nd division.

C H A P. 14

An Act respecting the organization, for municipal, judicial and registration purposes, of certain territories served by the National Transcontinental Railway

[Assented to 22nd December, 1916]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The territories described in section 5 are annexed to and form part of the district of Quebec for judicial purposes. Territory annexed to Quebec judicial district.

2. Paragraph 8 of article 73 of the Revised Statutes, R. S., 73, 1909, as amended by the act 1 George V (1st session), chapter 8, section 14, is further amended by adding thereto, in the description of the territory, the following paragraph, to wit:

“Less also, in the counties of Joliette and Berthier, the northwest parts, bounded on the southeast by the forty-eighth parallel of north latitude, and, in the county of Montcalm, the extreme northern corner, bounded on the south by the same parallel of north latitude, which form part of the judicial district of Quebec.”
