

## C H A P. 34

An Act to amend the law relating to coroners in the Province of Quebec

[Assented to 22nd December, 1916]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Article 3487bb of the Revised Statutes, 1909, as enacted by the act 4 George V, chapter 38, section 1, is amended by inserting therein, after the words: "sworn declaration", in the fifth line thereof, the words: "and of the verdict".

**2.** This act shall come into force on the day of its sanction.

## C H A P. 35

An Act to amend the Revised Statutes, 1909, concerning exhibitions of moving pictures

[Assented to 22nd December, 1916]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

R. S., 3713n,

**1.** Article 3713n of the Revised Statutes, 1909, as enacted by the act 3 George V, chapter 36, section 1, and amended by the acts 4 George V, chapter 40, section 6, and 5 George V, chapter 58, section 1, is further amended by replacing the words: "one dollar" in the sixth line of the fourth paragraph thereof by the following: "five dollars in the case of a film exchange or of twenty-five dollars in the case of any other person."

**2.** Article 3713p of the Revised Statutes, 1909, as enacted by the act 3 George V, chapter 36, section 1, and replaced by the act 4 George V, chapter 40, section 3, and amended by the act 5 George V, chapter 58, section 2, is again replaced by the following:

Fees to be  
paid on  
films, &c.

"**3713p.** Before the Commission may examine any film or device submitted to it for approval, the person

presenting such film or device must produce a receipt showing that he has paid to the collector of provincial revenue for the district of Montreal for each film or device as defined in the rules, a fee of five dollars in the case of a film exchange or a fee of twenty-five dollars in the case of any other person.

The provisions of article 1305 and following shall apply to the fees collected under this subsection." Provisions applicable.

**3.** Article 3713r of the Revised Statutes, 1909, as enacted by the act 3 George V, chapter 36, section 1, and replaced by the act 4 George V, chapter 40, section 5, is amended by replacing the second paragraph thereof by the following: R. S., 3713r, am.

"Every person who, with the intention of using the same, alters in a manner not approved by the commission any film or device approved by the commission, or who removes any part of such film or device before submitting the same to the commission, shall be liable to a fine of not less than five hundred dollars for each offence, and, in default of payment of such fine and costs, to imprisonment for three months." Alteration of film. Penalty.

**4.** Article 3713u of the Revised Statutes, 1909, as enacted by the act 3 George V, chapter 36, section 1, and amended by the act 5 George V, chapter 58, section 3, is further amended by adding thereto the following paragraph, to wit: R. S. 3713u, am.

"It shall be lawful for the Lieutenant-Governor in Council, by regulation, to reduce the fees mentioned in articles 3713n and 3713p." Fees.

**5.** The Revised Statutes, 1909, are amended by inserting therein, after article 3713u thereof, as enacted by the act 3 George V, chapter 36, section 1, and amended by the act 5 George V, chapter 58, section 3, the following article, to wit: R. S., 3713v, enacted.

"**3713v.** Every film or part of a film not claimed within sixty days of the date of the deposit thereof with the commission may be destroyed by the said commission." Films not claimed may be destroyed.

**6.** This act shall come into force on the day of its sanction. Coming into force.
