

of the municipal electors, or be designated by the Lieutenant-Governor when they are to be replaced by him.

No election or appointment may take place to fill the office of such councillors until they have been so selected by lot or designated."

Additional powers of council.

10. In addition to the powers conferred upon municipalities by the Municipal Code, the municipal council of the village of Petit Lac Magog may make, amend and repeal by-laws for the following purposes:

a. For erecting, maintaining and regulating public bath houses, club houses and wharves within the limits of the municipality;

b. For aiding the erection, building and maintenance of electric roads and lines within its limits and outside of the same, but leading thereto, and contribute to their establishment and maintenance.

Office may be outside the municipality.
Sittings of council.

11. The office of the municipality and that of the secretary-treasurer may be outside the municipality.

The first sitting of the council shall be held at the time and place fixed by the officer presiding at the election.

Until otherwise decided, under article 110 of the Municipal Code, the council shall sit at the place and spot chosen by the officer presiding at the election.

Coming into force.

12. This act shall come into force on the first juridical day of April, 1917.

C H A P. 87

An Act to extend the borrowing powers of the corporation of the village of Chambly Canton

[Assented to 22nd December, 1916]

Preamble.

WHEREAS the corporation of the village of Chambly Canton has, by its petition, represented:

That its floating debt is nine thousand dollars;

That in the interest of the health of its inhabitants, it is urgent that a system of public sewers be built, the cost whereof has been estimated by its engineer at forty-one thousand dollars, and improvements be made to its waterworks, and chiefly that the intake of the latter be changed to another place, and that a filter be installed at a cost of ten thousand dollars;

That under the provisions of the new Municipal Code, its borrowing power is exhausted, and it is necessary under the circumstances to obtain power to effect additional loans to consolidate its floating debt and to make the above mentioned improvements;

That the Superior Board of Health of the Province of Quebec has ordered the said corporation to make the said improvements;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Notwithstanding article 771 of the Quebec Municipal Code, the corporation of the village of Chambly ^{Loan authorized.} Canton is authorized to borrow the sum of sixty thousand dollars, fifty-one thousand dollars whereof shall be for the improvements above mentioned, and nine thousand dollars for consolidating its floating debt.

2. In every other respect, the provisions of the Quebec ^{Provisions applicable.} Municipal Code shall apply to such power to borrow.

C H A P. 88

An Act to amend the charter of the municipality of the village of Courville, in the county of Quebec, and to incorporate it as a town

[Assented to 22nd December, 1916]

WHEREAS the corporation of the village of Courville ^{Preamble.} has, by its petition, represented that its charter, the act 2 George V, chapter 76, no longer meets the needs of the municipality; that it wishes to be incorporated as a town under the name of "Courville", subject to the provisions of the Cities and Towns' act, and that it also requires an addition to its territory, and certain further powers to enable it to properly carry on the undertakings of public interest necessitated by its rapid growth;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:
