

Schools not affected. **19.** This act shall not affect the present division for school purposes of the territory abovementioned.

Coming into force. **20.** This act shall come into force on the day of its sanction.

## CHAP. 89

An Act to detach certain immoveables from the parish of St. Joachim in the county of Montmorency, and to form a separate parish under the name of St. Louis de Gonzague du Cap Tourmente

[Assented to 22nd December, 1916]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Territory erected into parish. **1.** The following immoveables belonging to the Quebec Seminary, and known on the official cadastre of the parish of Saint-Joachim, in the county of Montmorency, as Nos. 1, 2, 3, 4, 5, 6, 52, 54, that part of No. 56 bought from Napoléon Thomassin, 66, 67, 68, 70, 71, 72, 110, 111, 112, 113, 114, 115, 116, 117, 118, 119, 125, 126, 127, 128, 129, 130, 131, 132, 133, 134 less that part sold to Alfred Fortin, 140, 143, 144, 145, 146, 147, 148, 149, 150, 151, 152, 153, 154, 155, 156, 157, 158, 159, 160, 161, 162, 163, 391, 392 and that part of No. 451 not belonging to Achille Lachance, are detached from the parish of St-Joachim and shall form the parish of Saint-Louis de Gonzague de Cap Tourmente, for civil purposes.

Name.

Portions sold to revert to parish of St. Joachim. **2.** Any immoveable or part of any immoveable sold by the Quebec Seminary shall revert *de jure* to the territory of the parish of Saint-Joachim and shall become subject to the control of the corporation of the parish of Saint-Joachim and of the school corporation of the same parish.

No council. **3.** It shall not be necessary to organize a municipal council in this territory, which shall not form part of the county in which it is situated.

Seminary to maintain roads, &c. **4.** The Quebec Seminary shall be bound to maintain the roads, bridges and water-courses on its various immoveables, as every owner must do.

**5.** The Quebec Seminary shall, as regards the immoveables above described, remain liable for the payment of its share of the debts now due by the corporation of the parish of St. Joachim and by the school corporation of the same parish. Seminary to be liable for payment of share of debts.

The amount required for the payment of such debts shall, in due time and place, be apportioned on all the immoveable property of the municipality, but the immoveables belonging to the Seminary and hereby detached from the parish of St. Joachim shall be taxed only according to their valuation as entered on the valuation roll now in force. Apportionment. Proviso.

**6.** The immoveables so detached from the said parish shall continue to form part of the school municipality of the parish of St. Joachim. Nevertheless, the Quebec Seminary shall not be bound to contribute to the general expenses of the school corporation, but only to the expenses of districts Nos. 1 and 2, as they now exist. Schools.

The western portion of lot No. 68, as far as the by-road leading to lot No. 66 of said cadastre, and the immoveables known as the following numbers of the same cadastre, namely, 110, 111, 112, 113, 114, 115, 116, 117, 118, 119, 130, 131, 125, 126, 127, 128, 129, 132, 133, 140, 143, 144, 145, 146, 147, 148, 149, 150, 151, 152, 153, 154, 155, 156, 157, 158, 159, 160, 161, 162, 163 and 134—less that part sold to Alfred Fortin—shall be deemed to form part of district No. 1, the others shall be deemed to form part of district No. 2, and can be taxed only for the expenses of such districts respectively, but always according to their valuation as entered on the valuation roll now in force. Districts Nos. 1 and 2.

The procurator of the Quebec Seminary, or any other person appointed by a resolution of the directors of the said seminary, shall be *de jure* one of the commissioners for the administration of the schools of such two districts. Commissioner de jure.

**7.** This act shall come into force on the first day of January, 1917, for municipal purposes, and on the first day of July, 1917, for school purposes. Coming into force.
