

## CHAP. 115

An Act to incorporate "*L'Institut des Petites Sœurs Franciscaines de Marie de Montréal*"

[Assented to 22nd December, 1916]

## Preamble.

**W**HEREAS *Les Petites Sœurs Franciscaines de Marie de Montréal* have, by their petition, prayed to be incorporated, and it is expedient to grant their prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

## Corporation created.

**1.** Lumina Bolduc, in religion Sister Marie Dominique; Geneviève Larouche, in religion Sister Marie de la Purification; Aimée Marie Ouellet, in religion Sister Marie Aimée de Jésus; Alexina Marchand, in religion Sister Marie Joseph de la Croix, all residing in the town of Baie St. Paul, county of Charlevoix, and all persons who do now and shall hereafter form part of the said institute, in accordance with its rules and by-laws, are incorporated under the name of "*Les Petites Soeurs Franciscaines de Marie de Montréal*".

## General powers.

**2.** The corporation hereby constituted shall have perpetual succession. It may have a common seal which it may change at will, appear before the courts in the same manner as any person may do; borrow, sign bills of exchange, promissory notes; possess, accept and acquire, by any legal title, moveable and immoveable property, which it may sell, alienate, hypothecate, assign, lease, transfer or exchange or otherwise dispose of under any title whatsoever; provided, however, that the annual revenue from the immoveable property possessed by the corporation for purposes of revenue shall not exceed twenty thousand dollars.

## Corporate seat.

**3.** The corporate seat of the corporation shall be in the city of Montreal.

## Rules, by-laws, &amp;c.

**4.** The corporation shall be governed by the rules of the community of "*Les Petites Sœurs Franciscaines de Marie de la Baie St. Paul*", and may make rules or by-laws which it may afterwards amend or repeal, respecting the administration of its property, the direction of its houses or establishments, the election, the number and the powers of its directresses and of its officers, the attributes of its members, their admission and leaving, and generally

may adopt all by-laws not contrary to the laws in connection with the purposes of the said corporation.

**5.** The corporation may appoint officers, procurators Officers, &c. and administratrixes among its members, and define their powers; it may also appoint procurators outside the institute.

**6.** Any document bearing the signature of the super- Signatures. ior and of four councillors of the corporation, shall be considered as binding upon the corporation.

**7.** The corporation may, with the approval of the Powers. ecclesiastical authorities, carry on the various works under its constitution, especially the education of children, elementary and superior education, the establishing of novitiates, orphanages, nurseries, free schools and paying, boarding schools, work rooms, domestic science schools, industrial schools, reformatory schools, schools for the instruction of deaf mutes and the blind, homes, refuges for the aged or infirm and epileptics of both sexes, hospitals for the sick, dispensaries, asylums for the idiots and insane of both sexes.

**8.** The corporation and its members shall, as regards General all persons admitted into their hospitals, schools or asylums, powers. have the powers, rights and privileges granted to establishments of the same kind in the Province.

**9.** The corporation may devote itself to other occu- Idem. pations of a nature calculated to help it in maintaining itself, especially taking in lady or lay boarders who may desire to live in their houses, or carry on industries and dispose of the products thereof; provided they comply in this respect with the laws of the Province and the directions of the ecclesiastical authorities.

**10.** The said corporation shall, when thereunto re- Return to quired by the Provincial Secretary, transmit to the Lieuten- Lt. Gov. in ant-Governor in council a statement of its immoveable Council. property, a certified copy of its rules and by-laws, and the names of its officers.

**11.** Nothing in this act shall have the effect of taking Provisions the corporation out of the control of the provisions of to remain the charter and by-laws of any municipality in which applicable.

**12.** This act shall come into force on the day of its sanction.

## C H A P. 116

### An Act to incorporate Israel Foundation

*[Assented to 22nd December, 1916]*

Preamble.

**W**HEREAS the persons hereinafter mentioned have by their petition prayed to be incorporated under the name of "Mount Sinai Foundation", with the view of assisting the afflicted, and especially school children;

Whereas it is established by the last reports of the sanitary physicians of the city of Montreal, that a large number of the children attending school, suffer from diseases of the eyes, ears, nose, throat and teeth;

Whereas it is desirable, in the public interest, to spread the science of hygiene generally;

Whereas it is expedient to grant the prayer of the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Messrs. Simon Kalmanovitch, agent; Isidor Roth, agent; Isidor Popliger, advocate; Isaac Kert, notary; Hirsch Shapiro, agent; Isaac Jacobvitch, merchant; Haiman Kenner, merchant; Abraham L. Fraid, agent; Max Cohan, agent; Joseph Samuel Kellert, manager; and Agenor H. Tanner, advocate, all of the city and district of Montreal, are hereby incorporated with their successors, under the name of Israel Foundation.

**2.** The corporate seat of Israel Foundation shall be in the city of Montreal.

General  
powers.

**3.** The corporation shall have perpetual succession, and may have a common seal, with power to change or alter the same as often as it may deem expedient; and the corporation may, under the same name, contract and bind itself by contract, sue and be sued, plead and be impleaded in all courts and places in this Province. Nevertheless the members of the corporation shall in nowise be personally liable for the debts thereof.
