

That the General Council of the Bar of the Province of Quebec, at a meeting held on the 26th day of October, 1916, has approved the passing of an act to authorize the said Bar to admit your petitioner to practise the profession of law immediately after the sanction of the said act, and the Secretary of the said Council to grant him his certificate as an advocate, from the time of the sanction of the said act;

Whereas the petitioner has prayed that an act be passed for the above purposes; and it is expedient to grant such prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The Bar of the Province of Quebec is hereby authorized to immediately permit the said Nathaniel William Jacobs to practise as an advocate; and the Secretary of the General Council of the Bar to issue to him immediately his certificate as an advocate. Bar authorized to admit N. W. Jacobs to practice.

**2.** This act shall come into force on the day of its sanction. Coming into force.

## C H A P. 132

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit Leonide François Lavigne to the practice of medicine, surgery and obstetrics

[Assented to 22nd December, 1916]

**W**HEREAS Léonide François Lavigne, physician and surgeon, of the city of Montreal, has, by his petition, represented: Preamble.

That in June, 1916, he obtained a diploma of Doctor of Medicine from the School of Medicine and Surgery of Laval University in Montreal, after following the regular courses of the said school during the time required by law;

That he began to follow the courses of the said school before obtaining his certificate for the study of medicine;

That he possesses the necessary qualifications for the practice of medicine, surgery and obstetrics;

That he cannot at present receive his license to practise medicine, surgery and obstetrics in the Province of Quebec without special authorization from the Legislature;

That he is thereby caused an appreciable delay which is damaging to him;

That on the 27th of September, 1916, he obtained the consent of the College of Physicians and Surgeons of the Province of Quebec, to the passing of an act authorizing the said College to grant him the necessary license for practising his profession after passing the required examination;

Whereas it is expedient to grant the prayer to that effect contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The College of Physicians and Surgeons of the Province of Quebec is authorized to admit the said Léonide François Lavigne among its members, and to grant him the necessary license to practise medicine, surgery and obstetrics in the Province of Quebec, after passing the examinations required by the said college.

#### C H A P. 133

An Act to authorize Ernest Brault to practise medicine after passing the necessary examinations for obtaining a license before the College of Physicians and Surgeons of the Province of Quebec

[Assented to 22nd December, 1916]

Preamble.

**W**HEREAS Ernest Brault, of the city of Montreal, has, by his petition, represented:

That in September, 1910, he was admitted among the students of medicine and surgery of Laval University in Montreal, and followed the medical course of that University during the five years required by the regulations;

That in 1915 the said University granted him a diploma as Doctor of Medicine;

That on the 11th of July, 1915, he obtained from the College of Physicians and Surgeons of the Province of Quebec the certificate authorizing him to study medicine, which, through unavoidable causes, he was unable to obtain before entering the university;
