

That he is thereby caused an appreciable delay which is damaging to him;

That on the 27th of September, 1916, he obtained the consent of the College of Physicians and Surgeons of the Province of Quebec, to the passing of an act authorizing the said College to grant him the necessary license for practising his profession after passing the required examination;

Whereas it is expedient to grant the prayer to that effect contained in the said petition;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Physicians and Surgeons of the Province of Quebec is authorized to admit the said Léonide François Lavigne among its members, and to grant him the necessary license to practise medicine, surgery and obstetrics in the Province of Quebec, after passing the examinations required by the said college.

C H A P. 133

An Act to authorize Ernest Brault to practise medicine after passing the necessary examinations for obtaining a license before the College of Physicians and Surgeons of the Province of Quebec

[Assented to 22nd December, 1916]

Preamble.

WHEREAS Ernest Brault, of the city of Montreal, has, by his petition, represented:

That in September, 1910, he was admitted among the students of medicine and surgery of Laval University in Montreal, and followed the medical course of that University during the five years required by the regulations;

That in 1915 the said University granted him a diploma as Doctor of Medicine;

That on the 11th of July, 1915, he obtained from the College of Physicians and Surgeons of the Province of Quebec the certificate authorizing him to study medicine, which, through unavoidable causes, he was unable to obtain before entering the university;

That, in view of the above, the College of Physicians and Surgeons of the Province of Quebec has consented to the passing of an act authorizing him to practise medicine after passing the necessary medical examinations for obtaining a license, before the board of examiners of the said college;

Whereas the petitioner has prayed that an act be passed to that effect; and whereas it is expedient to grant his prayer;

Therefore His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The College of Physicians and Surgeons of the Province of Quebec is authorized to admit the said Ernest Brault among its members, and to grant him the necessary licence to practise medicine in the Province, after examination. College of Physicians and Surgeons authorized to admit E. Brault to practice.
2. This act shall come into force on the day of its sanction. Coming into force.

C H A P. 134

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Charles Henry Barr to the practice of dentistry

[Assented to 22nd December, 1916]

WHEREAS Charles Henry Barr, of the city and district of Montreal, doctor of dental science, has been admitted to follow and has followed a complete course and taken clinical training in dentistry in the school of dental surgery of McGill University, Montreal, from which, after due examination, he has graduated and received the diploma of doctor of dental science on the 13th of September, 1916; Preamble.

Whereas he has, in consequence of his studies and experience, all the knowledge and title required of a practising dental surgeon, and the necessary competence to practise as such;

Whereas since obtaining said diploma of doctor of dental science, he has been prevented from being examined by the Board of Governors of the College of Dental Surgeons of the Province of Quebec for the practice of dentistry, owing to the fact that he only completed on the 13th of
